NOTICE AND DIGEST

AN ORDINANCE AMENDING CHAPTER 15.12, SECTION 114.3 OF THE OAKLAND FIRE CODE TO AUTHORIZE USE OF THE LIEN PROCESS TO RE-COVER UNPAID ADMINISTRATION AND REINSPECTION FEES, FINES, INTEREST, PENAL-TIES, AND COLLECTION FEES AND OTHER COSTS ASSOCIATED WITH ENFORCEMENT OF THE FIRE CODE

Revising the Oakland Municipal Code Chapter 15.12, Fre Code, Section 114.3 "Method of Collection: Additional Amount of Costs to Tax Bill Procedure," will enable the City to recover costs the City incurred while conducting compliance inspections for hazardous vegetation inspections, when real property is found noncompliant after the first inspection. The Amendment will allow the City to use the lien process to recover unpaid administrative and re-inspection fees, fines, penalties, interest, and collection fees from non-compliant property owners at the rates established and described in the Master Fee Schedule.
