EXECUTIVE SUMMARY

This report covers the period from January 1, 2016 to March 31, 2016. It responds to the Community and Economic Development (CED) Committee's request for a standing quarterly report to track economic development activities and actions (Attachment A). This quarter's report has been reformatted to include a smaller sample of business development highlights while providing more details about these activities.

Company	Sector	District	Employees	Notes/Status/Business Needs
Flax Art & Design (attraction)	Retail	3	20	Flax Art Store determined that Oakland offered a great location for its flagship store, not only because of affordability, but the centralized location that 1501 MLK Way offers to its patrons as well as the growing market for its products. Economic Development staff confirmed the attributes of the location and, along with the City's Public Information Officer, brainstormed a comprehensive list of publicity and partnership opportunities. The Project Implementation Division supplied \$154,000 in matching tenant improvement (interior) façade matching grants.
Forge Kitchen (attraction)	Food/Beverage Manufacturing	3	15	Forge Kitchen a culinary co-working space that relocated from San Francisco to a 2,700-square-foot warehouse at 478 25th Street. Forge Kitchen will include offices, a commercial kitchen, maker space and a small café in which chefs can sell products. Economic Development staff is assisting the business in the coordination of EBMUD and City permitting issues.
Gatorade Oakland facility (retention)	Food/Beverage Manufacturing	5	80-100	PepsiCo's Gatorade bottling plant is located at 5625 International Blvd. in a 157,000-square-foot facility. Economic Development staff is working with new General Manager regarding workforce development services, additional street lighting needs, a planned BRT Station near the site, and possible access to the adjacent GE plant site for parking and other uses.

Impossible Foods (attraction)	Food/Beverage Manufacturing	7	25	Impossible Foods is a well funded start-up that creates plant-based meat and cheese substitutes. Its first product—the Impossible Burger—is set to launch in the U.S. next year with its production plant in Oakland at the former 65,000 square foot Just Desserts facility at 550 85th Avenue. The Oakland operation will start with 25 employees — involved in R&D all the way to full production. Impossible Foods is also planning for future expansion needs. Economic Development staff has facilitated introductions to City leadership and the surrounding business community, assisted with navigation of the City's permit requirements, and supported the company's executives with information about the City's workforce development services and economic development plans.
Learners Guild (attraction)	Tech	3	n/a	Learners Guild, a California B-Corporation, is a network of guild-style professional schools that offer accelerated software developer training in one year. The company is located at 492 9th Street and will start its Oakland program in July. Economic Development staff provided site search assistance and introductions. The program has no upfront costs and provides a living allowance. Tuition is paid back only when graduates begin a job that pays over \$60,000 a year.
Mayvenn (attraction)	Tech	3	60+	Mayvenn is an innovative direct sales/e-commerce company and stylist platform selling African American hair products. The company was originally founded in Oakland. Staff conducted site searches, facilitated workforce development services, and assisted with business registration and permitting requirements for their return back to Oakland. The company recently raised \$10 million in venture capital after previously raising \$3 million in seed funding – for a total of \$13 million for the startup. Founder and CEO Diishan Imira is underway with exploring other product lines.

Green & Cleantech	3	~50	leading marketplace lenders in the residential solar power industry. Mosaic recently moved its operations from the Powerhouse solar incubator/accelerator to its own, standalone offices at 1212 Broadway. Additionally, this B-Corporation has recently raised \$200M in private equity funding.
			The "Shops on Broadway" development, located at Broadway and 30th Street, is the first major development completed in the Broadway Valdez Specific Plan area. The 36,000 square foot development includes a Sprouts Grocery Store and 10,000 square feet of additional retail, with approximately 150 retail related jobs. Economic Development staff has worked with the
Retail	3	150	investor/developer for over three years to implement this project. Services included determination of environmental
			impact report requirements, planning and building permit coordination, introductions to community and City leadership, and facilitation with City departments as needed or requested
			by client. The project includes public spaces at ground level and a parking garage rooftop, and is consistent with the Broadway Valdez Specific Plans retail development goals.
Green & Cleantech	3	375+	Sungevity is one of Oakland's premier large employers. The company has recently signed a new 10-year lease at 66 Franklin Street and is planning for its long term expansion in Oakland. Economic Development staff has offered to assist with coordination of building permits required for tenant improvements. In 2015, Sungevity secured \$650 million in equity and project financing, making it the largest financing of a private company in the solar industry for that year.
	Retail Green &	Retail 3	Retail 3 150 Green & 3 375+

Jeremy's (attraction)	Retail	3	30	A discount fashion emporium, Jeremy's purchased the 114-year-old, 10,000 square foot First Christ the Scientist church in the Uptown neighborhood, doubling the size of its current Berkeley location in Elmwood (and formerly also in South Park, San Francisco). Coordinating with Project Implementation staff, Economic Development staff provided support with permit processing, introductions to the Lake Merritt Uptown Community Benefit District, and key City departments. In addition to a creative reuse of an historic resource, Jeremy's will likely catalyze further shopping in the area. Jeremy's "will be Oakland's largest designer apparel and shoe store since I. Magnin closed in 1995," according to the San Francisco Chronicle.
Hegenberger Shopping Center – Walmart Store Closure	Retail	7	400	As part of its global restructuring plans, 269 Walmart stores in the U.S. were closed, including the Oakland Walmart store in early February 2016. Staff is maintaining communications with Walmart corporate staff regarding workforce impacts, real estate actions, and property management coordination. Staff has had productive meetings with the property owner and Walmart's brokers, and are maintaining communications with other property representatives. Staff has worked with Walmart local brokers to explore viable retail users.
Coliseum Shopping Center	Retail	7	NA	The Coliseum Shopping Center located at 640 Hegenberger Road was once a thriving neighborhood shopping center. The Center is currently in receivership. Staff facilitated a meeting with the previous property owner, lenders, retailers and City offices. Staff is currently working with the lender's representatives to explore reuse or redevelopment of the site including maintaining a mix of community retail and retail/production uses.


Activity Highlights

- ➤ Sponsored the *Good Local Money for Your Good Local Business* funding guide, produced by the East Bay Express and the Sustainable Business Alliance, and offering detailed technical information on capitalizing local business initiatives from crowd funding to traditional loans to angel investors.
- In coordination with Port of Oakland staff, and colleagues in the Public Works Agency (PWA) and Oakland Police Department (OPD), worked collaboratively to reactivate the heavyweight trucking route, which is critical to several port users, and had become inaccessible in recent months due to some mixed signals from Caltrans.
- ➤ In coordination with OPD and the Downtown Oakland Association, and in the wake of the January 5th, 2016 fatal shooting in the neighborhood, Economic Development staff assisted with the formation of a new Merchant Watch group for property owners and merchants near Broadway and 13th Street, including the Integral Group, the Wine Merchants restaurant, and owner/property managers of 1330 and 1212 Broadway, among others; this group is now meeting monthly to flag problems and track progress.
- As part of the administration of the Oakland/Berkeley Recycling Market Development Zone (RMDZ), successfully secured \$13,500 in Zone Incentive Funds for outreach and promotion over the next three fiscal years (through June 30, 2018).
- Assisted new ownership for former BIMBO Bread plant (District 5) and former Svenhard's Baking (District 3) with introductions to community, businesses and City leaders; facilitated permitting processes and provided support with tenant businesses recommendations. Both are former industrial baking plants that are being reutilized to support current market production, warehouse and distribution uses.
- ➤ Assisted ALPI International, CWS and Silverado in their PWA and East Bay Municipal Utility District (EBMUD) processes for a street vacation, driveways and utilities.
- Facilitating development and investment interest in the Owens Illinois Plant property in coordination with other City departments, site ownership and owner representatives (District 5).

- ➤ Facilitated redevelopment opportunities: Parkway Theater, Lake Merritt Bakery marketing, Chinatown properties (District 2).
- ➤ ED Staff participated in Champion Street NODO development (District 4); Fairfax neighborhood tour/meetings (District 4).
- ➤ Coordinated Eastmont Town Center ownership project, facilitating development of the MacArthur Business Association with information regarding the business improvement district formation process (District 6).
- > TechHire: City helped sign on 25 Oakland-based and East Bay employers as participants in the East Bay Tech Hire Initiative, a proposal to expand the tech career pipeline for underserved Oakland and East Bay youth.
- ➤ Startup in Residence (STIR): the Economic and Workforce Development Department hosted an innovative procurement process, with the San Francisco Mayor's Office of Innovation and Cities of San Leandro and West Sacramento, to allow startups to respond to civic challenges developed by City of Oakland departments. Startups will spend four months in a pro bono residency with extensive expert support to co-create digital service delivery solutions with Oakland city staff.
- ➤ Startup In a Day: Economic Development staff worked with the Digital Front Door team and Code for America to create a new online portal for businesses that combines the licensing, permitting, and support services in one digital interface. The new portal is under construction with a soft launch that occurred during Oakland Small Business Week.
- ➤ Provided comments and reference information to City Administrator Office staff documenting the probable impact of passage of the proposed cannabis zoning and regulation ordinance on overall industrial rents, and on non-cannabis industrial businesses.
- > Secured \$56,000 in Broadway Shuttle private sponsorships from the Downtown and Lake Merritt Community Benefit Districts, and the Jack London Improvement District.
- Economic Development staff helped form the Embarcadero Cove Business Alert in collaboration with PWA, OPD, Coast Guard, and area businesses. Addressed issues regarding abandoned and blighted boats, abated vagrancy, and mitigation strategies regarding the impacts of homeless encampments and reported crime (District 5).

- City of Oakland recently endorsed 15 more Kiva Zip loans for Oakland small businesses, bringing the City endorsed total to 40. \$88,425 in loans ranging from \$2,500-\$10,000 were disbursed to 11 Kiva Zip loan recipients.
- The Business Assistance Center conducted five Kiva Zip Workshops.
- Business Assistance Center (BAC) Legal Clinic: the monthly clinic, staffed by pro bono attorneys from the Bay Area's top legal firms, provides free legal advice to small businesses in the form of 30-minute individual consultations in English, Spanish, Vietnamese and Chinese. For the first quarter of 2016, a total of 82 clients attended.

Special Project and Event Highlights

- Assisted in coordination of the Oakland Kiva City launch event, co-hosted by the City of Oakland and held at the Oakland Museum on March 16, 2016. Close to 1,000 attendees.
- ➤ Organized table at the 4th Annual East Bay Innovation Awards, hosted at the Fox Theater and featuring four Oakland finalists in the Food (winner Core Foods and OCHO Candy), Education (Hack the Hood), and Information Technology (Clef) categories.
- ➤ TechEquity Week February 23-March 3rd: Oakland hosted the nation's first Tech Equity Week, sponsored by the City and convened by Oakland firm Qeyno Labs with the Rainbow Push Coalition, Oakland-based Alliance for Community Development and Tech Equity Collaborative. Events included the Capital Connections Conference, Hacking Housing competition co-hosted by Kapor Center and SPUR, and the 2.Oak/ReadySet panel "Broadening the Pipeline: Strategies for Diversifying Your Workforce." United Roots, Pandora, Uptima Business Bootcamp, and the My Brother's Keeper student hackathon were also part of the program.
- ➤ Participated in working meeting with Code for America fellows regarding developing more comprehensive and friendlier new business online portal.
- > Supported the creation of the Oakland Business Improvement District (BID) Alliance, the association of the eleven Oakland BIDs to help facilitate better coordination between business and property owners, and the City of Oakland.












Sales Tax Real Estate Transfer Tax Transient Occupancy Tax








Rainin Foundation Launches New Grant Program for Local Artists

The Kenneth Rainin Foundation announced a new arts program, Open Space, to fund up to four temporary public art projects with grants between \$50,000 and \$200,000 per project. The program aims to "engage communities, showcase artistic experimentation and energize public spaces." Oakland Mayor Libby Schaaf stated, "Programs like Open Spaces help ensure that the arts are supported and celebrated in Oakland." The foundation is accepting Letters of Inquiry between May 16 and June 30. Kenneth Rainin was the founder of East Oaklandbased Rainin Instruments, one of Oakland's largest manufacturers.

AECOM Bringing 600 Workers to Kaiser Center

The Bay Area's largest engineering and design firm, <u>AECOM</u>, <u>has secured a major office lease</u> in Downtown Oakland. AECOM is taking 120,000 square feet in the Kaiser Center at 300 Lakeside Drive. The new location, two blocks from BART with lake views, will bring together 600 workers currently at AECOM's two San Francisco locations and its current Oakland office at 1313 Broadway.
