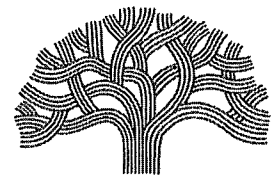

INTRODUCED BY COUNCIL PRESIDENT LYNETTE GIBSON MCELHANEY

RESOLUTION REAPPOINTING DAN KALB AS A MEMBER OF THE ALAMEDA COUNTY WASTE MANAGEMENT AUTHORITY (ACWMA) AND APPOINTING COUNCILMEMBER GUILLÉN AS AN ALTERNATE MEMBER OF THE ACWMA

WHEREAS, the City of Oakland is one of the agencies that entered into a Joint Exercise of Powers Agreement for Waste Management as amended November 10, 1992; and

WHEREAS, the City of Oakland may appoint one member and one alternate member to the ACWMA Board; and

WHEREAS, Councilmember Dan Kalb was previously appointed a member and Councilmember Rebecca Kaplan was previously appointed an alternate member of the ACWMA (Resolution 84259 C.M.S); and

WHEREAS, the City Council's Rules of Procedure (Resolution No. 82580 C.M.S.) provide that "the President of the Council shall recommend appointments to regional and local boards and agencies, as appropriate, subject to confirmation by the Council"; now, therefore be it

RESOLVED: That Councilmember Dan Kalb is hereby reappointed to the ACWMA Board; and be it further

FURTHER RESOLVED: That Councilmember Abel Guillén is hereby appointed as alternate member of the ACWMA Board replacing Councilmember Rebecca Kaplan.
