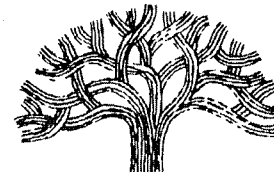





## RESOLUTION APPOINTING, ON THE MAYOR'S RECOMMENDATION, ROBERT STEVEN WILKINSON AS A MEMBER OF THE POLICE AND FIRE RETIREMENT BOARD

**WHEREAS**, Section 601 of the Oakland City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

**WHEREAS**, Oakland City Charter, Article XXVI establishes the Police and Fire Retirement Board to manage and administer the Police and Fire Retirement System which provides retirement benefits for certain sworn police and fire personnel; and

**WHEREAS**, the Police and Fire Retirement Board consists of seven members including, but not limited to, a life insurance executive of a local office; and

**WHEREAS**, the Honorable Mayor Libby Schaaf recommends incumbent Robert Steven Wilkinson be appointed to serve another five-year term on the Police and Fire Retirement Board in the seat designated for a life insurance executive of a local office, subject to appointment by the City Council; now therefore be it

**RESOLVED**, that pursuant to City Charter section 601, the City Council Hereby appoints, on the Mayor's recommendation, Robert Steven Wilkinson to the Police and Fire Retirement Board in the seat designated for a life insurance executive of a local office, for the five year term beginning September 1, 2016 and ending August 31, 2021, filling the seat currently holds.
