WHEREAS, Annette Fountaine was an active participant, representing Oakland Fire Department's Fire Dispatch Center at the Alameda County Fire Chiefs' Communications Section meetings; and

**WHEREAS,** Annette Fountaine was and is known for her candor, distinctive voice, technical knowledge and tireless work ethic; now, therefore be it
