RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR OR DESIGNEE TO ACCEPT AND APPROPRIATE THE FY 2015-16 STATE OF CALIFORNIA CITIZENS OPTIONS FOR PUBLIC SAFETY GRANT (STATE COPS GRANT XVIII) IN THE AMOUNT OF SIX HUNDRED FORTY-ONE THOUSAND EIGHT HUNDRED TWELVE DOLLARS (\$641,812) TO FUND EQUIPMENT, HUMAN TRAFFICKING OPERATIONS AND CEASEFIRE OPERATIONS FOR THE OAKLAND POLICE DEPARTMENT (OPD) IN ACCORDANCE WITH THE STATE COPS XVIII SPENDING PLAN.

WHEREAS, the State Legislature estimated that funds in the amount of six hundred forty-one thousand eight hundred twelve dollars (\$641,812) would be allocated in "pass-through" funding for the FY2015 State of California's "Citizen's Options for Public Safety" Grant (State COPS Grant XVIII) which was distributed to Alameda County and then transferred to OPD; and

WHEREAS, funds must be used to support front-line police operations and must supplement, not supplant existing police funding; and

WHEREAS, funds will be used for equipment, Human Trafficking operations and Ceasefire operations in accordance with the spending plan; and

WHEREAS, in the past five years, City Council approved Resolution No. 84863 C.M.S., Resolution No. 84218 C.M.S., and Resolution No. 83491 C.M.S. to accept and appropriate State COPS Grant funds; and

WHEREAS, funds for this grant will be allocated in the State of California Grant Fund (2158); Fiscal Services Division Org (106510); State COPS XVIII Project (G453630); Agency-wide Administration Program (PS01); therefore be it

RESOLVED: that the City Council authorizes the City Administrator or designee to accept and appropriate the State COPS Grant XVIII allocation in the amount of six hundred forty-one thousand eight hundred twelve dollars (\$641,812) plus accrued interest earnings, for OPD to be used for the purchase of equipment, Human Trafficking Operations and Ceasefire Operations in accordance with the spending plan for the grant period of July 1, 2015 through June 30, 2017; and be it

FURTHER RESOLVED: that the City Council hereby authorizes the City Administrator or designee, to accept and appropriate additional funds received for the State COPS Grant XVIII, up to ten thousand dollars (\$10,000) for the grant period of July 1, 2015 through June 30, 2017, without returning to Council; and be it

FURTHER RESOLVED: that revenues and appropriations will be allocated to the State of California Grant Fund (2158); Fiscal Services Division Org (106510); State COPS XVIII Project (G453630); Agency-wide Administration Program (PS01); and be it

FURTHER RESOLVED: that all contracts issued hereunder shall be reviewed and approved by the City Attorney for form and legality and copies shall be placed on file in the City Clerk's Office.
