

INTRODUCED BY PRESIDENT PRO TEM LARRY REID

RESOLUTION AUTHORIZING A GRANT OF \$25,000 FROM COUNCIL MEMBER LARRY REID'S GRAFFITI ABATEMENT MURAL AND GREEN WALLS FUNDS TO THE EAST OAKLAND BEAUTIFICATION COUNCIL TO DETER ILLEGAL GRAFFITI IN COUNCIL DISTRICT 7 AND FOR ADDITIONAL EFFECTIVE ABATEMENT AND DETERENCE METHODS TO DETER ILLEGAL GRAFFITI

WHEREAS, On June 27th, 2013 the City Council set aside Graffiti Abatement Funds for Murals and Green Walls in the amount of \$50,000 for each Council Member to address graffiti within their districts; and

WHEREAS, areas in District 7 are in state of graffiti blight and in need of graffiti abatement; and

WHEREAS, Council Member Larry Reid wishes to grant \$25,000 of his Graffiti Mural and Green Wall Funds to the East Oakland Beautification Council to eradicate graffiti blight and to beautify the culturally rich District, as well as to abate and deter graffiti; and

WHEREAS, In conformance with City requirements, the East Oakland Beautification Council will provide documentation for the use of the Council Member's Graffiti Abatement Mural and Green Wall Funds; now therefore be it

RESOLVED: That the City Council authorizes the use of \$25,000 from Council Member Larry Reid's Graffiti Abatement Mural and Green Wall Funds for a grant to the East Oakland Beautification Council to eradicate graffiti blight and

to beautify the culturally rich District, as well as to abate and deter graffiti; and be it

FURTHER RESOLVED: That the City Administrator is authorized to execute a grant agreement with the East Oakland Beautification Council in the amount of \$25,000 for the above purpose, subject to approval as to form and legality by the City Attorney.


