RESOLUTION AUTHORIZING A GRANT NOT TO EXCEED \$8,000 FROM COUNCILMEMBER KALB'S GRAFFITI ABATEMENT MURAL AND GREEN WALL FUNDS TO NORTH OAKLAND COMMUNITY CHARTER SCHOOL (NOCCS) FOR A MURAL ON THE PROPERTY AT 1000 42ND STREET (WALL FACING LINDEN PARK) IN OAKLAND

WHEREAS, on June 27, 2013, the City Council adopted a budget that set aside graffiti abatement funds for murals and green walls for Oakland City Councilmembers to award at their discretion, subject to Council approval, in an effort to address graffiti within their districts; and

WHEREAS, the property of North Oakland Community Charter School (NOCCS) for a mural on the property at 1000 42nd street (wall facing Linden park) is currently in a state of graffiti blight; and

WHEREAS, Councilmember Kalb wishes to grant a portion of his Graffiti Abatement Mural and Green Wall Funds to North Oakland Community Charter School (NOCCS) for a mural on the property at 1000 42nd street (wall facing Linden park) to abate and deter graffiti; and

WHEREAS, in conformance with City requirements, North Oakland Community Charter School (NOCCS) will provide documentation for the use of the Councilmember's Graffiti Abatement Mural and Green Wall funds, including any permits required and permission from the property owner to install the mural; now, therefore, be it

**RESOLVED:** That the City Council authorizes a grant not to exceed \$8,000 from Councilmember Kalb's graffiti abatement mural and green wall funds to North Oakland Community Charter School (NOCCS) for a mural on the property at 1000 42nd street (wall facing Linden park) in Oakland; and be it

**FURTHER RESOLVED:** That the City Administrator is authorized to execute a grant agreement with the artist North Oakland Community Charter School (NOCCS) for the above purpose, subject to approval as to form and legality by the City Attorney.
