RG14753212, CITY ATTORNEY'S FILE NO. 30121, IN THE AMOUNT OF SEVENTY-FIVE THOUSAND DOLLARS AND ZERO CENTS (\$75,000.00) (OAKLAND PUBLIC WORKS – DANGEROUS CONDITION)

**WHEREAS,** Plaintiff Tracy Hobbs alleges that she sustained injuries resulting from a bicycle accident on January 27, 2014; and

**WHEREAS**, without admitting fault or wrongdoing, the City has determined to compromise and settle Plaintiff's claims against it for the sum of Seventy-Five Thousand Dollars and No Cents (\$75,000.00); now, therefore, be it
