President Gibson McElhaney and Members of the City Council:

Pursuant to Section 401 of the Charter, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled claim for the sum of Seven Thousand Four Hundred Twenty Dollars and 43/100 Cents (\$7,420.43), made payable to CSAA Insurance Exchange a/s/o Jeanne Foss-Swaine.

This action arises out of a January 17, 2015 incident in which CSAA Insurance Exchange claims property damage to their insured's vehicle as a result of a collision with an OPD vehicle.

The Council authorized settlement of this case in Closed Session on Tuesday, October 18, 2016 (moved by Councilmember Larry Reid and seconded by Councilmember Abel Guillén – 6 Ayes, 2 Absent - Councilmembers Desley Brooks and President Lynette Gibson McElhaney).
