INTRODUCED BY COUNCILMEMBER DAN KALB

**RESOLUTION AUTHORIZING A GRANT NOT TO EXCEED \$9,450 FROM COUNCILMEMBER KALB'S GRAFFITI ABATEMENT MURAL AND GREEN WALL FUNDS TO ARTIST LORI ANNE FISCHER WITH THE SUPPORT OF THE TEMESCAL-TELEGRAPH BUSINESS IMPROVEMENT DISTRICT FOR A MURAL ON THE PROPERTY AT 4685 TELEGRAPH AVENUE IN THE TEMESCAL NEIGHBORHOOD**

**WHEREAS**, on June 27, 2013, the City Council adopted a budget that set aside graffiti abatement funds for murals and green walls for Oakland City Councilmembers to award at their discretion, subject to Council approval, in an effort to address graffiti within their districts; and

**WHEREAS**, the property at 4685 Telegraph Avenue in the Temescal neighborhood is currently in a state of graffiti blight; and

**WHEREAS**, Lori Anne Fischer completed several murals throughout the City of Oakland and gained significant support from the local residents and businesses for her work; and

**WHEREAS**, Councilmember Kalb wishes to grant a portion of his Graffiti Abatement Mural and Green Wall Funds to artist Lori Anne Fischer for a mural on the property at 4685 Telegraph Avenue in the Temescal neighborhood with the support of the Temescal-Telegraph Business Improvement District; and

**WHEREAS**, in conformance with City requirements, artist Lori Anne Fischer will provide documentation for the use of the Councilmember's Graffiti Abatement Mural and Green Wall funds, including any permits required and permission from the property owner to install the mural; now, therefore, be it

**RESOLVED:** That the City Council authorizes a grant not to exceed \$9,450 from Councilmember Kalb's graffiti abatement mural and green wall funds to artist Lori Anne Fischer for a mural on the property at 4685 Telegraph Avenue in the Temescal neighborhood in Oakland; and be it

**FURTHER RESOLVED:** That the City Administrator is authorized to execute a grant agreement with the artist Lori Anne Fischer for the above purpose, subject to approval as to form and legality by the City Attorney.


