### Additional edits to resolution re: Local Employment Program

**1. Title:** Keep last clause of original resolution title (underlined), so title reads:

## **RESOLUTION DIRECTING REVISIONS TO LOCAL EMPLOYMENT AND APPRENTICE UTILIZATION REQUIREMENTS CONTAINED WITHIN THE CITY'S LOCAL AND SMALL LOCAL BUSINESS ENTERPRISE PROGRAM, <u>REQUIRING CONTRACTORS TO HIRE</u> OAKLAND RESIDENTS TO IMPLEMENT PROGRAM REVISION**

**2.** Third-to-last "Whereas" clause: revise clause with the underlined insertions and deletion so it reads as follows:

WHEREAS, in February of 2012, the City through administrative action released the City's current Local and Small Local Business Enterprise Program, which contains the City's small/local business requirements, the Local Employment Program, and the 15% <u>Oakland</u> Apprenticeship <u>Utilization Policy requirement</u>; and

**3. Second-to-last "Whereas" clause:** revise with the underlined insertions so it reads as follows:
