RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO 1) AMEND THE 2016-2017 OAKLAND PATH REHOUSING INITIATIVE GRANT AGREEMENT WITH ABODE SERVICES TO INCREASE THE GRANT AMOUNT BY \$354,168 FOR THE PROVISION OF PERMANENT HOUSING AND SUPPORTIVE SERVICES, AND 2) AMEND THE 2016-2017 OAKLAND PATH REHOUSING INITIATIVE GRANT AGREEMENT WITH FIRST PLACE FOR YOUTH TO INCREASE THE GRANT AMOUNT BY \$72,050 FOR THE PROVISION OF PERMANENT HOUSING AND SUPPORTIVE SERVICES

WHEREAS, Oakland City Council Resolution No. 79923 C.M.S. authorizes the development and implementation of the City of Oakland's Permanent Access to Housing (PATH) strategy to end homelessness; and

WHEREAS, pursuant to the PATH strategy, the Oakland Housing Authority (OHA) has partnered with the City since July 2010, to implement the Oakland PATH Re-Housing Initiative (OPRI) to fund rental housing subsidies for homeless individuals living in encampments, individuals exiting the criminal justice system and youths exiting probation and foster care; and

WHEREAS, Oakland City Council Resolution No. 85583 C.M.S. authorizes the City of Oakland to accept and appropriate funds from OHA in FY 2015-2016 and Fiscal Year (FY) 2016-2017 and enter into grant agreements with ABODE Services for \$1,291,000 and with First Place for Youth for \$209,000 to provide permanent housing and support services to homeless single adults, and transition aged youth under the OPRI program in FY 2015-206 and FY 2016-2017; and

WHEREAS, the OHA Sponsor Based Housing Assistance Program is a one year funding cycle and the allocation from OHA increased to \$1,926,218 in FY 2016-2017; and

WHEREAS, the City desires to increase the FY 2016-2017 grant agreement with ABODE Services to add up to \$354,168 for a total grant amount of \$1,645,168 for housing search and placement, annual housing inspections, and landlord/tenant mediations to homeless adults for FY 2016-2017; and

WHEREAS, the City desires to increase the FY 2016-2017 grant agreement with First Place for Youth to add up to \$72,050 for a total grant amount of \$281,050 for housing search and placement, annual housing inspections, and landlord/tenant mediations to homeless transition age youth for FY 2016-2017; now therefore, be it

RESOLVED: That the City Administrator is hereby authorized to amend the FY 2016-2017 grant agreement with ABODE Services to increase the grant amount by up to \$354,168 for housing search and placement, annual housing inspections, and landlord/tenant mediations to homeless adults for FY 2016-2017; and be it

FURTHER RESOLVED: That the City Administrator is hereby authorized to amend the FY 2016-2017 grant agreement with First Place for Youth to increase the grant amount by up to \$72,050 for housing search and placement, annual housing inspections, and landlord/tenant mediations to homeless transition age youth for FY 2016-2017; and be it

FURTHER RESOLVED: That funding for the increases in the grant agreements with ABODE Services and First Place for Youth are available in the HUD-ESG/SHP/HOPWA Fund (2103), Community Housing Services Org (78411), Third Party: Grant Contracts Earned Account (54912), FY1617 OPRI-OHA ABODE/1st Place for Youth Projects (G487515/ G487525) and Fostering Safe and Healthy Communities Program (SC22).

FURTHER RESOLVED: That the City Council authorizes the City Administrator to conduct all negotiations, execute and submit all documents, including but not limited to applications, agreements, amendments, modifications, payment requests, and related actions which may be necessary for the above-referenced grant agreements, including increasing the grant amount within the grant term (FY 2016-2017) without returning to Council; and be it

FURTHER RESOLVED: That said grant agreements shall be reviewed as to form and legality by the Office of the City Attorney and copies will be filed in the Office of the City Clerk.
