The purpose of this memorandum (memo) summarizes the status of the items on the Life Enrichment Committee (LEC) pending list. It contains staff's recommendations for new report frequencies. These updates would refresh the pending list to reflect current situations with each of the programs addressed. Staff will update the Life Enrichment Committees pending list after confirmation of changes below.

Report	Current Pending List Frequency	Staff Recommended New Frequency
1 - Oakland Fund for Children and Youth (standing item)	Monthly Report Last heard on May 22, 2012	Staff recommends that this report be combined with #5 in this report which is one of two annual OFCY reports (the other annual report is the funding recommendations). If there is information in this previous report of interest to the LEC Committee it be added to the #5 annual report.
2 - Dunsmuir Hellman Historic Estate [per LEC 3/22/11]	Semi-annual Report Last heard March 22, 2011	The OPR Director is looking into this. Staff recommends replacing this semi-annual report with an annual report. Staff also recommends replacing this Dunsmuir-specific report with a general report about all of OPR's large facilities.
3 - Library Advisory Commission	Semi-annual Report Last heard April 26, 2016	This report is consistently presented on an annual basis and should be switched to an annual report as the expectation with the ability for the LAC to bring a second report in any given year.

Report	Current Pending List Frequency	Staff Recommended New Frequency
4 - Cultural Affairs Commission	Semi-annual Report Last heard December 2, 2014	Staff recommends that this be an annual report. A new director was just hired and staff recommends waiting for the new director to provide an update on when this report can be brought back.
5 - Planning & Oversight Committee, Oakland Fund for Children and Youth – Eval Report	Semi-annual Report Last heard on January 26, 2016	Staff recommends that this report be changed from a semi-annual report to an annual report and include any report elements from #1 above. An annual report has been the practice and this is the frequency at which the evaluation reports are provided by the third party evaluator.
6 - OFCY Jan, 2015 - 3-4 Year Plan	Semi-annual Report	This report comes on a tri- yearly basis. A status update on the progress of OFCY programs comes on an annual basis. Staff recommends that the pending list show this at no less than as an annual report.
7 - Community Action Partnership Administering Board	Annual Report Last heard January 27, 2015	Staff recommends no change to this report except for a title change. It is an annual report and will be brought to LEC in November or December 2016 with the new title of 'Oakland Community Action Partnership (OCAP) Community Services Block Grant.'

Report	Current Pending List Frequency	Staff Recommended New Frequency
8 - Mayor's Commission on Aging	Annual Report Last heard May 28, 2013	Staff recommends to keep this as an annual report. It has not been brought to LEC due to lack of consistent quorum at the Commission level. Staff anticipates being able to bring the report in April 2017.
9 - Head Start Policy Council	Annual Report Last heard November 16, 2010	Staff recommends that this item be updated to be an annual report about the Head Start program. Such a report could include information on the Head Start Policy Council.
10 - Mayor's Commission on Persons with Disabilities	Annual Report Last heard May 28, 2014	Staff recommends keeping this as an annual report. It has not been brought to LEC due to lack of consistent quorum at the Commission level. Staff should be able to bring a report in late 2016 or early 2017.
11 - Paramount Theater of the Arts Board	Annual Report Last heard May 28, 2013	Staff has no recommendation for this item, but a report should be presented.
12 - Parks and Recreation Advisory Commission	Annual Report Last heard July 22, 2014	Staff recommends that this remain as an annual report. The new OPR Director will work with the PRAC to bring the next report.
13 - Youth Advisory Commission	Annual Report Last heard June 11, 2013	Staff recommends that this stay as an annual report. The Youth Commission staff will work to get the YAC in a place to get an annual report scheduled. The delay is due to staffing changes.
