#### RECOMMENDATION

Council President Lynette Gibson McElhaney Recommends That The City Council Adopt the 2017 Legislative Calendar for the City Council and Council Committee Meeting, Report and Distribution Schedule.

#### **BACKGROUND / LEGISLATIVE HISTORY**

Rule 7 of the City Council's Rules of Procedure (Resolution 86034 C.M.S) requires that City Council meetings are held on the first and third Tuesdays of every month. Fifth Tuesdays are utilized for Special Meetings and workshops. Rule 4 of the Council's Rules of Procedures requires that Council Standing Committees are held on the second and fourth Tuesdays of every month. Additionally, Rule 20 requires that August 1 through August 31 is the City Council's Annual Recess. Given the requirements of the Rules of Procedure, the draft calendar has been generated with the corresponding meeting dates, report deadlines and agenda distribution dates.

#### **EXPLANATION OF SCHEDULE:**

#### A. Spring Recess

The proposed dates for Council's Spring Recess on April 3, 2017 through April 7, 2017 coincide with the Oakland Unified School District's Spring Recess.

#### B. Summer Recess

The proposed dates for Council's Summer Recess allow for ending the legislative session following a Council meeting rather than having legislative matters from Council Committees carry over into the fall. The week of July 24-28, 2017, will be reserved for Special Meetings, if necessary.

#### C. Thanksgiving Recess

The standard practice of the City Council is to cancel all meetings during the week of Thanksgiving. The proposed dates for Council's Thanksgiving Recess would therefore be Monday, November 20 through Friday, November 24, 2017.

### B. Cancel Council Committee Meetings during the week of January 9th, 2017

The Council President recommends the City Council meeting on January, 10<sup>th</sup> 2017 be cancelled as it is the official inauguration meeting for the City of Oakland.

### C. Cancel Council Meetings for the Week of September 4th, 2017

The Council President recommends the City Council meeting of September 5<sup>th</sup>, 2017 and the Rules & Legislation Committee meeting of September 7<sup>th</sup>, 2017 be cancelled as it is the week after Labor Day.
