WHEREAS, the Honorable Mayor Libby Schaaf has reappointed Midori Tabata, Fred McWilliams and Kenya Wheeler to each serve on the Bicyclist and Pedestrian Advisory Commission subject to confirmation by the City Council; now therefore be it **RESOLVED:** that pursuant to City Charter section 601, the City Council hereby confirms the Mayor's reappointment of:

**Midori Tabata**, to serve a three-year term on the Bicyclist and Pedestrian Advisory Commission beginning January 1, 2017 and ending December 31, 2020, retaining the seat she currently holds.
