ARNOLD X.C. PERKINS

Arnold X. C. Perkins served as Director of the Alameda County Public Health Department in Oakland, California from 1994 through 2006. As Director he provided leadership and management of the administrative, research, epidemiology, program, and policy activities of the department. During his tenure, the Department's budget increased from \$55 million to over \$107 million, serving 1.4 million people. He also brings diverse experience and a deep commitment to building and maintaining the spirit of community.

During his tenure, Mr. Perkins led the Department through a major organizational shift that reflects a broad vision of Public Health with a community development orientation. He believes that public health is a social change organization that must be integrated into the community and responsive to its needs.

His diverse background also includes positions as a foundation program officer and advisor; non-profit organization executive director; high school teacher and principal; family counselor and advocate; and college teacher, researcher, and administrator.


