- 1. PAGE 6, SECTION 5.80.020 C -- Delete LAST SENTENCE THAT REQUIRES A RFP for Equity permit applicants.
- Add to Definition Section J AND USE THROUGHOUT ORDINANCES: <u>"Equity Applicant"</u> <u>shall mean an Applicant whose ownership IS AN OAKLAND RESIDENT AND has an annual</u> <u>income at or less than 80 percent of Oakland Average Medium Income (AMI) adjusted</u> <u>for household size and either (i) has lived in any combination of Oakland police beats 2X,</u> <u>2Y, 6X, 7X, 19X, 21X, 21Y, 23X, 26Y, 27X, 27Y, 29X, 30X, 30Y, 31Y, 32X, 33X, 34X, and 35X</u> <u>for at least five of the last ten years or (ii) was arrested after November 5, 1996 and</u> <u>convicted of a cannabis crime committed in Oakland, California.</u>
- 3. Section 5.80.045 (A)(1) ADD BACK IN: BE AN OAKLAND RESIDENT WHO HAS.
- 4. ADD McElhaney Amendments.
- 5. ADD Section 2 below TO THE REVIEW CRITERIA IN 5.80 AND 5.81
 - B. Review of Criteria.
 - <u>1. Proof of Income shall be supported with verified federal tax returns and</u> <u>at least one of the following documents: two months of pay stubs,</u> <u>current Profit and Loss Statement, or Balance Sheet.</u>
 - 2. A minimum of the two of the following documents shall be required in order to demonstrate proof of Oakland Residency: California Driver's Record or Identification Card, property tax bills, copies of tax returns, utility bills, vehicle registration.

The list below provides the documents acceptable as proof of Oakland residency. A minimum of two (2) acceptable documents are required. All residency documents must list the applicant's first and last name, and the Oakland residence address must match the residence address listed on the cannabis application:

- <u>California Driver's Record indicating TEN consecutive years at an Oakland</u> <u>address;</u>
- <u>California Identification Card Record indicating TEN consecutive years at an</u> <u>Oakland address;</u>
- <u>TEN consecutive years of Property tax billing and payments;</u>
- <u>TEN consecutive years of Verified copies of State or Federal income tax returns</u> where an Oakland address is listed as the primary address;
- <u>Utility company billing and payment covering any month in each of the TEN</u> <u>consecutive years prior to the application submission;</u>
 - 3. Proof of Incarceration should be demonstrated through Department of Corrections or Federal Bureau of Prisons documentation.

- 6. Appropriate \$200,000 from the general fund to pay for the first year for a consultant to administer zero interest loans and provide technical assistance, preparation of business plans and compliance with all applicable law. AND reimburse those funds from the incoming business taxes collected pursuant to both Section 5.04.480 and 5.04.481 of the Oakland Municipal Code from cannabis operations.
- 7. REPORT BACK IN JULY.
- 8. 3 YEAR RESIDENCY REQUIREMENT ON THE GENERAL PERMIT.
- 9. APPLICANT SEEKING TO ENGAGE IN THE PRODUCTION OF INFUSED EDIBLE CANNABIS PRODUCTS AND TOPICALS MAY BE LOCATED IN PERMITTED COMMERCIAL KITCHENS LOCATED IN COMMERCIAL ZONES.
