RESOLUTION APPROVING A CONTRACT WITH HARVEY M. ROSE ASSOCIATES, LLC, UP TO \$80,000, TO CONDUCT AN INDEPENDENT ANALYSIS OF THE MAYOR'S PROPOSED FY 2017-19 BUDGET, AND ADDITIONAL ANALYSES, AS NEEDED AND IF DIRECTED, PENDING AVAILABILITY OF FUNDS, FOR THE ENTIRE CITY COUNCIL, TO REPORT DIRECTLY TO THE PRESIDENT OF THE COUNCIL AND THE CHAIR OF THE FINANCE AND MANAGEMENT COMMITTEE, AND TO WORK COLLEGIALLY WITH THE CITY ADMINISTRATOR. OR HER DESIGNEE, TO OBTAIN RELEVANT INFORMATION, INCLUDING, BUT NOT LIMITED TO, PAST BUDGET DOCUMENTS, MEMORANDA, REPORTS AND **OTHER INFORMATION** NECESSARY TO EXECUTE THE ANALYSIS IN A TIMELY MANNER

WHEREAS, an informational report was heard at the July 12, 2016, Finance and Management Committee to discuss options for creating the position of Council Budget and Finance Analyst; and

WHEREAS, based on the recommendation of the July 12, 2016, Finance and Management Committee, an amount of \$80,000 was set aside by the City Council in the FY 2016-17 budget to use for a limited-duration employee or contractor to serve as an independent Budget and Finance analyst for the entire Council, reporting to the Council President and Finance and Management Committee Chair; and

WHEREAS, Council staff developed a scope of services for the responsibilities of this position, a request for proposals/qualifications was conducted and Harvey M. Rose Associates, LLC, was selected; and

WHEREAS, Harvey M. Rose Associates, LLC, will analyze the following topics: multi-year budget-to-actual expenditures and revenues with a focus on police, fire, information technology, and planning and building operations and services; major areas of budget-year increases, including increases in the number of staff FTEs; salary savings; encumbrance and reserve adjustments; and potential revenue enhancement options, with a focus on property, sales, documentary transfer, utility, and business license fees; and

WHEREAS, the contract with Harvey M. Rose Associates, LLC is capped at \$79,000 and ends December 31, 2017, the Council may request additional analysis following the passage of the FY.

RESOLVED: That a contract with Harvey M. Rose Associates, LLC, is hereby approved in an amount of seventy nine thousand dollars (\$79,000) to conduct an independent Budget and Finance analysis of the Mayor's proposed FY 2017-19 budget for the entire City Council in connection with the FY 2017-19 budget development process; and, be it

FURTHER RESOLVED: That in addition to the independent analysis referenced above of the proposed FY 2017-19 budget Harvey M. Rose & Associates, LLC, may conduct additional analyses as needed and if directed, pending the availability of funds, will report directly to the President of the Council and the Chair of the Finance and Management Committee, and will work collegially with the City Administrator, or her designee, to obtain relevant information including, but not limited to, past budget documents, memoranda, reports and other information as necessary to execute the scope of work in a timely manner.
