## INTRODUCED BY COUNCILMEMBER DESLEY BROOKS

RESOLUTION DECLARING APRIL 9 THROUGH 15, 2017 AS NATIONAL PUBLIC SAFETY TELECOMMUNICATORS WEEK IN THE CITY OF OAKLAND
