#### RECOMMENDATION

Staff Recommends That The City Council Adopt A Resolution Authorizing the City Administrator, or Designee, To Award and Execute A Series Of Professional Services Agreements For On-Call Landscape Architectural Services For A Period of Three (3) Years With the Following Firms: 1) Bottomley Associates; 2) Carducci Associates; 3) Community Design and Architecture; 4) Dillingham Associates; 5) Einwiller Kuehl, Inc.; 6) Hood Design Studio, Inc.; 7) Merrill Morris Partners; 8) Office of Cheryl Barton; 9) PGA Design; 10) Placeworks, Inc.; 11) RHAA Landscape Architects; and 12) WRT Inc.; Each For An Amount Not To Exceed Five Hundred Thousand Dollars (\$500,000.00).

#### **EXECUTIVE SUMMARY**

On-call professional services provide various architectural and engineering services to support the City's Capital Improvement Program. Services are necessary for projects to provide site assessment, concept design, landscaping, construction document preparation, bid and construction support. The services address issues such as code requirements, Americans with Disabilities Act (ADA) compliance, and project scope needs. Staff utilizes these services for various projects such as parks, tot lots, athletic fields, and landscaping.

Approval of this resolution will authorize the City Administrator to enter into professional services agreements to provide on-call landscape architectural services to meet the above needs with each of the following twelve firms:

#### BACKGROUND

Since 2003 on-call professional services have been competitively selected and serve as a tool in the delivery of capital improvement projects. The services are utilized as projects arise and allow for expeditious contracting of required design/engineering services. The continued use of on-call professional services will allow staff to respond and implement capital projects that are anticipated, including those resulting from the recently approved Infrastructure Bond as well as on-going capital projects. To continue utilizing on-call professional services, the City issued a Request for Qualifications (RFQ) in January 2017 for on-call landscape architectural design services and recommends contracting with the proposed firms.

#### ANALYSIS AND POLICY ALTERNATIVES

In response to the RFQ, eighteen (18) firms submitted Statement of Qualifications. A panel comprised of one Parks Services staff member, one Parks and Recreation staff member, one Public Works staff member, and a landscape architectural professional representative from the City and County of San Francisco reviewed and ranked the proposals based on the quality and content of the proposals. The evaluation criteria for the selection included the following:

- 1. Relevant experience and strengths of the firm; demonstrated ability to deliver exceptional projects; particularly within the restraints of municipal or other public agency budgets and process.
- 2. Prior experience and ability to work with City/public agency staff, community groups and other stakeholders, and translating various requirements and interests into successful projects.
- 3. Specific experience of the firm to provide adept technical assistance, project management and quality assurance/quality control for a broad range of landscape architectural projects. Depth of staff and resources to deliver quality products on schedule, including work on short notice and under time constraints.
- 4. Firm's experience providing sustainable / resilient design solutions. Priority was given to Landscape Architects and Irrigation Consultants who have 'Bay-Friendly Certified' staff.

The twelve (12) firms recommended are well-qualified to provide on-call landscape architectural design services. Six (6) of the twelve firms are certified local or small local businesses. All 12 firms meet the City's Local/Small Local Business Enterprise (L/SLBE) program requirements and will be compliant with the City's Equal Benefits Ordinance. The Social Equity Division of the Department of Contracting and Purchasing has verified the L/SLBE information for each firm (see **Attachment A** – Contract Compliance Memo).

Item: \_\_\_\_\_ Public Works Committee July 11,2017 The 12 selected firms have the technical expertise to perform the work required, and clearly demonstrated their understanding of the technical complexities and regulatory issues involved in implementing public capital improvement projects.

The on-call resources will provide support to a myriad of project types such as park improvements, park planning, grant preparation design, site improvements, streetscape project support, sports fields, tot lots, plaza improvements, trails and pathways, and urban greening projects, etc. Given the recent passage of Measure KK - Infrastructure Bond, it is anticipated that the professional contracts will be utilized in the delivery of the proposed capital program. The proposed Infrastructure Bond projects include several parks and tot lot projects of approximately \$2 million, as well as developing complete street projects for 17 grants for a potential project budget of \$5 million. Staff is also finalizing the development of the Park Project Prioritization list of projects. Out of the 21 Park Project Prioritization projects, over half of the projects will need the services of landscape professionals if implemented. In addition, Measure DD Bond (Clean Water & Safe Parks Bond) allocated approximately \$9.7 million in Series C funds for Lake Merritt and Waterfront projects to focus on completing designs within the next two years. Remaining Measure WW Bond (East Bay Regional Park Bond) projects will all be able to utilize the on-call services to some level of the design for preliminarily scope or to implement the project fully. The availability of the professional services will continue to allow staff to respond swiftly and support community-initiated, public-private partnership projects which has historically ranged up to 6 projects per year.

#### **FISCAL IMPACT**

The on-call landscape architectural design services will be required for projects funded by various capital improvement funds, bonds, and grants. As-needed professional services agreements will expedite the design of capital improvement projects. The time and costs necessary in selecting consultants on a project-by-project basis will be saved. In addition, approval of these contracts will not result in additional appropriation of funds. The services will be funded through appropriations by individual projects. Funds will be identified prior to the performance of the design services. Each agreement for consultants will be for an amount not to exceed \$500,000.00.

#### **PUBLIC OUTREACH / INTEREST**

In October 2016, three months before the RFQ was issued, Oakland Public Works – Project Delivery Division (OPW-PDD) engaged the Office of the City Administrator - Contract & Compliance Division to help define opportunities, ideas and strategies for enhancing outreach effort to local and diverse firms. Contract & Compliance provided OPW-PDD a list of local S/LBE firms, and agreed to reach out to local firms whose LBE/SLBE certification status had lapsed to encourage them to renew their registration. The release of the RFQ in January allowed time for these firms to become re-certified. Prior to issuing the RFQ, OPW-PDD also notified all active local Landscape Architecture firms on the City's certified local business list, as well as all Landscape Architecture firms listed in the Oakland Yellow Pages, of the upcoming RFQ opportunity and encouraged their submittal. Additionally, OPW-PDD contacted the local Chapter

Item: \_\_\_\_\_ Public Works Committee July 11,2017 of the American Society of Landscape Architects (ASLA) and conducted an online search to inform them of the upcoming RFQ.

In January 2017, the RFQ was advertised in local papers whose circulation is recognized to reach local and diverse audiences: Oakland Tribune, El Mundo, Oakland Post and Sing Tao. The RFQ was posted on iSupplier and CIPlist.com; which are widely accessed and often redistributed by other list serve business organizations that provide notice of RFQ/P opportunities to local firms; including: the Oakland Metropolitan Chamber of Commerce, Oakland Black Board of Trade & Commerce, Bay Area Business Roundtable, and Construction Bidboard.

#### **COORDINATION**

This report and legislation have been reviewed by the Office of the City Attorney, Controller's Bureau and Contracts and Compliance Division of the City Administrator's Office.

#### SUSTAINABLE OPPORTUNITIES

*Economic*: The consultants are all verified for Local Business Enterprise and Small Local Business Enterprise (LBE/SLBE) participation by the Social Equity Division of the Department of Contracting and Purchasing. The projects will generate business tax, sales tax, and other revenues for the City by those firms who work on the project. Local businesses will be utilized on the projects and will benefit directly.

**Environmental**: One factor in the selection of firms was their demonstrated experience providing sustainable / resilient design solutions. Priority was given to Landscape Architects and Irrigation Consultants who have 'Bay-Friendly Certified' staff. Consultants will be required to consider the use of recycled materials in the products specified and to integrate other environmental, waste reduction and energy conservation opportunities.

**Social Equity**: The proposed landscape architectural design services for capital improvement projects will result in reducing blight to neighborhoods, and in enhancing various parks and facilities to support increased recreational opportunities. The resulting projects will comply with Americans with Disabilities Act (ADA) and enhance the enjoyment of our public spaces for all ages and abilities.

Staff Recommends that The City Council approve a resolution authorizing the City Administrator to award and execute professional services agreements for on-call landscape architectural services for a period of three years in an amount not to exceed five hundred thousand dollars (\$500,000.00) each for the firms specified in the resolution.

**<u>Comments</u>**: As noted above, all firms met the minimum 50% L/SLBE participation requirement. Firms that are not EBO compliant must come into compliance prior to full contract execution.





**RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR, OR** DESIGNEE, AWARD AND EXECUTE Α SERIES OF TO PROFESSIONAL SERVICES **AGREEMENTS** FOR **ON-CALL** LANDSCAPE ARCHITECTURAL SERVICES FOR A PERIOD OF THREE (3) YEARS WITH THE FOLLOWING FIRMS: 1) BOTTOMLEY ASSOCIATES; 2) CARDUCCI ASSOCIATES; 3) COMMUNITY DESIGN AND **ARCHITECTURE:** 4) **DILLINGHAM ASSOCIATES:** 5) EINWILLER KUEHL, INC.; 6) HOOD DESIGN STUDIO, INC.; 7) **MERRILL MORRIS PARTNERS; 8) OFFICE OF CHERYL BARTON; 9)** 10) PLACEWORKS, INC.; 11) RHAA LANDSCAPE PGA DESIGN: ARCHITECTS; AND 12) WRT INC.; EACH FOR AN AMOUNT NOT TO **EXCEED FIVE HUNDRED THOUSAND DOLLARS (\$500,000.00)** 

WHEREAS, on-call professional services provide various architectural and engineering services to support the City's Capital Improvement Program; and

WHEREAS, services are necessary for projects to provide site assessment, concept design, landscaping, construction document preparation, bid and construction support; and

WHEREAS, the services address issues such as code requirements, Americans with Disabilities Act (ADA) compliance, project scope needs, and staff utilizes these services for various projects such as parks, tot lots, athletic fields, and landscaping; and

**WHEREAS,** the City conducted a competitive Request for Qualifications process for professional services, and eighteen firms submitted Statement of Qualifications; and

**WHEREAS,** the recommended firms have proposed and will be required to meet City's Compliance programs through the course of the contract; and

WHEREAS, the City wishes to enter into a contract with each of the firms; and

**WHEREAS**, the City Council finds that the professional design services are exempt from competitive bidding pursuant to Oakland Municipal Code Section 2.04.051 A; and

WHEREAS, the City Council finds that this agreement is for professional services; and

WHEREAS, the City Council finds and determines that the performance of this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive services; now, therefore, be it

**RESOLVED:** That the City Administrator, or designee, is hereby authorized to enter into Agreement each with 1) Bottomley Associates; 2) Carducci Associates; 3) Community Design and Architecture; 4) Dillingham Associates; 5) Einwiller Kuehl, Inc.; 6) Hood Design Studio, Inc.; 7) Merrill Morris Partners; 8) Office of Cheryl Barton; 9) PGA Design; 10) Placeworks, Inc.; 11) RHAA Landscape Architects; and 12) WRT Inc. to provide on-call landscape architectural design services; and be it

**FURTHER RESOLVED:** That the total amount of each Agreement is for an amount not to exceed Five Hundred and Thousand Dollars (\$500,000); and be it

**FURTHER RESOLVED:** That the contract term will be for three (3) years from the date of contract execution; and be it

**FURTHER RESOLVED:** That funding for each project utilizing the on-call services will be identified and available prior to issuing task orders for the services; and be it

**FURTHER RESOLVED:** That the contracted firm(s) shall comply with all City contracting and compliance program requirements that apply to this contract, including Local Business Enterprise and Small Local Business Enterprise (LBE/SLBE) participation and be verified by the Contracts and Compliance Division; and be it

**FURTHER RESOLVED:** That the City Administrator, or designee, is hereby authorized to approve any subsequent amendments to or extensions of said agreement with the exception of those related to an increase in total compensation or the allocation of additional funds, provided that such amendments or extensions shall be filed with the City Clerk's Office; and be it

**FURTHER RESOLVED:** That a copy of the Agreement will be on file in the City Clerk's Office and will be approved for form and legality by the Office of the City Attorney.
