RESOLUTION INITIATING THE FISCAL YEAR (FY) 2017-18 ASSESSMENT PROCESS FOR THE CITY OF OAKLAND LANDSCAPING AND LIGHTING ASSESSMENT DISTRICT WITH THE INTENTION TO LEVY ASSESSMENTS FOR THE CITY OF OAKLAND LANDSCAPING AND LIGHTING ASSESSMENT DISTRICT (LLAD), ACCEPT THE FY 2017-18 PRELIMINARY ENGINEER'S REPORT, AND SET JUNE 20, 2017 AT 6:30PM AS THE DATE AND TIME FOR A PUBLIC HEARING.

WHEREAS, pursuant to the California Streets and Highways Code, Sections 22500, et seq., known as the Landscaping and Lighting Act of 1972, the City has taken a series of actions preliminary to ordering the establishment of the Landscaping and Lighting Assessment District ("District") and established such District on June 23, 1989; and

WHEREAS, pursuant to the California Streets and Highway Code Sections 22500, et seq., the City has renewed the District each subsequent year; and

WHEREAS, the voters of the City of Oakland previously approved the continuation of the District; and

WHEREAS, annually, the City Administrator files with the City Clerk, reports for the continuation of the District in order to raise revenues for the installation, maintenance, and servicing of public landscaping and lighting; and

WHEREAS, the City desires to initiate the FY 2017-18 LLAD assessment for properties within the district boundaries; and

WHEREAS, the District Engineer submitted a Preliminary Engineer's Report for the District confirming the applicability of the existing assessment rates for FY 2017-18, which is on file with the City Clerk; and

WHEREAS, the City desires to levy and collect assessments within the City of Oakland Landscaping and Lighting Assessment District for the FY 2017-18 LLAD assessment for properties within the district boundaries; now, therefore be it

RESOLVED: That the existing boundaries of the LLAD remain the same as those described in the FY 2016-17 Engineer's Report approved by the City Council, Resolution No. 86220 C.M.S., on June 7, 2016; and be it

FURTHER RESOLVED: That the City Council intends to levy and collect assessments within the City of Oakland Landscaping and Lighting Assessment District for FY 2017-18; and be it

FURTHER RESOLVED: That the City Council accepts the Preliminary Engineer's Report for the District, which describes the existing and proposed improvements and any substantial changes proposed to be made in existing improvements, for discussion purposes; and be it

FURTHER RESOLVED: That the Preliminary Engineer's Report is attached as Exhibit A to the Resolution; and be it

FURTHER RESOLVED: That all the area of land to be assessed is located in the City of Oakland, Alameda County; and be it

FURTHER RESOLVED: That a public hearing is set for June 20, 2017 at 6:30 p.m., or soon thereafter as the item may be heard, in the City Council Chambers, Oakland City Hall, One Frank H. Ogawa Plaza, Oakland, California regarding the FY 2017-18 Landscaping and Lighting Assessment District and the levy of assessments; and be it

FURTHER RESOLVED: That the Office of the City Administrator is directed to publish notice of the public hearing no later than June 9, 2017.
