

RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO AWARD A CONTRACT TO FRANCISCO ELECTRIC SUPPLY, A CORPORATION, THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, A SMALL LOCAL BUSINESS ENTERPRISE TO PROVIDE STREETLIGHT TRAFFIC SIGNAL STANDARDS ACCESSORIES IN THE ANNUAL AMOUNT NOT TO EXCEED ONE MILLION FOUR HUNDRED THOUSAND DOLLARS (\$1,400,000.00) FOR THE PERIOD OF AUGUST 1, 2017 TO JULY 31, 2018 IN ACCORDANCE WITH THE TERMS AND CONDITIONS IN SPECIFICATION 17-550-00/RFQ 34411.

WHEREAS, on April 21, 2017 in accordance with Oakland Municipal Code (OMC) 2.04.050 the City issued and advertised Specification No. 17-550-00/ RFQ 34411 to provide Streetlight Traffic Signal Standards and Accessories; and

WHEREAS, on May 8, 2017 the City Clerk received and opened bids in response to Specification No. 17-550-00/ RFQ 34411; and

WHEREAS, the bid submitted by Francisco Electric Supply was evaluated and deemed the lowest responsive and responsible bidder and meets all the requirements contained in Specification No. 17-550-00/ RFQ 34411 to provide Streetlight Traffic Signal Standards and Accessories; and

WHEREAS, all proposed contract expenditure allocations shall be expensed to the Oakland Public Works Electrical Services Division, Bureau of Infrastructure and Operations, Lighting and Landscape Assessment District, Electrical Services: Maintenance Organization, Supplies: Electrical and Plumbing now, therefore be it.

RESOLVED, that a contract be awarded to Francisco Electric Supply, a company, the lowest responsive and responsible bidder, a small local business enterprise, in an annual amount not to exceed one million four hundred thousand dollars (\$1,400,000.00) for the period of August, 1, 2017 to July 31, 2018 to provide Streetlight Traffic Signal Standards and Accessories; and

FURTHER RESOLVED, that the City Council hereby rejects all other bids submitted in response to Specification No. 17-550-00/ RFQ 34411; and

FURTHER RESOLVED, that the contract shall be approved for form and legality by the City Attorney and copies shall be on file in the City Clerk's Office.


