NOTICE AND DIGEST AN ORDINANCE: (1) Amending The Term Sheet For The Disposition And Development Agree-ment For The Properties Located At 3455 And 3461 Champion Street Previously Approved By Ordinance Number 13400 C.M.S. To Modify The Project Schedule, Including Extending The Outside Dates For Closing And Comple-tion Of Construction, And The Hours Of Oper-ation; And (2) Authorizing The City Adminis-trator, Without Returning To The City Council, To Negotiate And Execute Such Disposition And Development Agreement And Related Documents Between The City of Oakland And Carlos Soloman And Dominica Rice-Soloman (Or Their Related Entities Or Affiliates), All Of The Foregoing Documents To Be In A Form And Content Substantially in Conformance With The Amended Term Sheet Attached As Exhibit A

Ordinance Number 13400 C.M.S. dated October 13, 2016 authorized the sale of the Champion Street Properties to Carlos Soloman and Dom-inica Rice-Soloman, under certain conditions and requirements.

Adoption of this Ordinance authorizes changes to said conditions and requirements of the sale; (a) extending the deadline for buyer to remove property inspection and financing con-tingencies from March 31, 2017 to the date that is sixty-one (61) days after execution of the DDA, but in no event later than September 30, 2017 (Item 21); (b) extending the deadline to close escrow from May 30, 2017 to January 1, 2018 (Item 22); (c) extending the construction commencement date from July 30, 2017 to March 1, 2018 (Item 23); (d) extending the Con-struction completion deadline from February 28, 2018 to March 30, 2019 (Item 24); (e) extend-ing the deadline for Dusiness opening from May 15, 2018 to April 30, 2019 (Item 25); and (f) modifying the business hours of operation to provide for operation from 11:00 a.m. to 11:00 p.m., Tuesday through Sunday, closed Monday and on major holidays.
