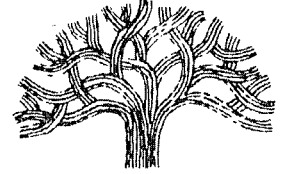

**WHEREAS**, Ordinance No. 13140 C.M.S., adopted October 30, 2012, established the Community Jobs Oversight Commission to monitor compliance with the construction and operations jobs policies for the former Oakland Army Base; and

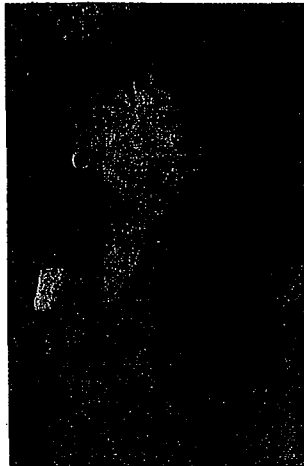

Camacho is an Oakland native and one of 10 children, raised by parents from the island of Guam. She began her career as a telephone operator and member of Communication Workers of America, worked at the City of Oakland as a member of SEIU, and then rose to become an SEIU Organizing Coordinator for 15 years.

Camacho is also on the Oakland Workforce Investment Board and Employer Strategies Co-Chair and sits on Congresswoman Barbara Lee's advisory committee, and boards of Asian Immigrant Women Advocates and Urban Peace Movement. She was also a founder of the national Asian Pacific American Labor Alliance APALA and currently serves as 1st Vice President of the only national organization composed of Asian Pacific Islander union members.

Before coming to the Alameda Labor Council, Camacho was Director of Constituent Services for Oakland Mayor Dellums from 2007-09. In 2009, Camacho served as Political & Staff Director at the Alameda Labor Council, became Acting Executive Secretary-Treasurer in 2010, leading the largest political program in its history, winning 53 of 59 top priority races with 3,000 volunteer shifts. Eventually Camacho was elected Executive Secretary-Treasurer becoming the first Pacific Islander to run one of the largest Labor Councils in the nation. Josie was re-elected for a second term as Executive Secretary-Treasurer. Under her leadership, in 2012, the Council received the "Highest Performing Labor Councils Achievement Award" from the California Labor Federation for the outstanding work and victory to defeat Proposition 32 and pass Proposition 30. The Alameda Labor Council is composed of 109 affiliated local unions, representing 100,000 union members in healthcare, transportation, education, construction, manufacturing, and service in Alameda County.



## **Biography of Margaret Gordon**

**Margaret Gordon** is the winner 2004 award winner given by the East Bay Community Foundation. The "Effect Giving" award, honors volunteer work for all of Alameda County. Ms. Gordon is one of the founding members of West Oakland Environmental Indicator Project. As a member she contributed to the development of two community-base participatory research reports; the "Neighborhood Knowledge for Change" and "Reducing Diesel Pollution in West Oakland". Her concerns with asthma in West Oakland has lead to the improved of health education for people with asthma through her work with the West Oakland Asthma Education Center, and the West Oakland Asthma Coalition. Ms. Gordon herself, was diagnosed with asthma and allergies as child. She was instrumental with the design of the 7<sup>th</sup> St/McClymonds Corridor Neighborhood Improvement Initiative. Ms. Gordon participated in pre-planning organizing, planning phase, governance development, and board member, also became the Outreach and Events Coordinator as staff for 7<sup>th</sup> St/McClymonds. She was also a participating member for Chester Street Block Associate, title IV federal compliant against CALTRAN, for not cleaning the vinyl choric plumb, found during construction of Cypress Freeway Replacement, and was one of co-chairs of the Community Advisory for Cypress Freeway Replacement.

Ms. Gordon is a co-writer of the Healthy Home Indoor Air Quality Project that covers the reducing diesel exposure for residents in West Oakland. The **West Oakland Healthy Homes Collaborative (WOHHC)** is a community collaborative that aims to improve the knowledge base, prevention, and intervention awareness of residents about indoor air quality, diesel pollution, and community health in West Oakland. The Collaborative efforts are based in the formation of working groups with residents and agency regulators (City of Oakland and Alameda County) to develop a Healthy Homes Model for West Oakland that reduces diesel exposure for local residents. This Model includes monitoring the indoor air quality of apartments, homes, and workplaces in West Oakland and implementing effective interventions to reduce exposures, as well as establishing advocacy campaigns citywide for public policies that prioritize diesel reduction and other preventative measures.

### **Ditching Dirty Diesel: Regional Conference Aims to Clear the Air**

In October 04, as staff of the Pacific Institute's Community Strategies for Sustainability and Justice, Ms. Gordon was a planner and presenter for the San Francisco Bay area's first regional conference on reducing diesel pollution and improving public was, according to participants, was a strong success. "Ditching Dirty Diesel" brought together community organizations, environmentalists, public health groups like the American Lung Association, and government officials to focus on asthma and other health problems related to diesel air pollution. Diesel pollution, which is prevalent in neighborhoods with heavy truck traffic, has been identified as a key trigger and even a cause of asthma and other health problems.

Ms. Gordon is a founding member of the **Alameda County Stakeholder Project for the Environmental Health Tracking Project**, the participation process will help CEHTP to determine if tracking can be useful to communities and for promoting public interests. We will use input to create and disseminate pilot project materials in ways that are most accessible and useful to stakeholders. Lessons learned from this process will also inform the planning of statewide and national tracking networks. Without this participation, it will be difficult to create a tracking network that fulfills its potential as a resource for all organizations, particularly those that directly serve the community.
