RECOMMENDATION

Staff Recommends That The City Council Approve A Resolution Accepting The Selection Panel's Slate of Four Police Commissioners (Mubarak Ahmad, José Dorado, Ginale Harris, Mike Nisperos) And One Alternate (Maureen Benson) To Serve On The City Of Oakland Police Commission.

EXECUTIVE SUMMARY

City Council approval of the resolution will accept the Selection Panel's slate of individuals to serve on the Police Commission as follows:

Mubarak Ahmad Maureen Benson (alternate) José Dorado Ginale Harris Mike Nisperos

BACKGROUND / LEGISLATIVE HISTORY

On November 8, 2016, Oakland voters approved Measure LL - Establishing a Police Commission with 83.19% (137,032 votes) in favor of the measure. Measure LL establishes a seven-member Police Commission, with two alternate commissioners, charged with overseeing the Oakland Police Department to ensure that its policies, practices and customs meet national standards of constitutional policing. Duties of the Police Commissioners include overseeing the Community Police Review Agency, which will conduct investigations into allegations of officer misconduct; proposing changes to, approving, or rejecting current or proposed Department policies; removing the Chief of Police for cause; as well as other duties.

ANALYSIS AND POLICY ALTERNATIVES

Appointment of the seven-member Police Commission requires that the Mayor submit three members and one alternate member to the City Council to accept or reject, and that a nine-member Selection Panel review applications, interview applicants, and submit a slate of Police Commissioners, including four regular members and one alternate member to the City Council to accept or reject.

On May 31, 2017, the Selection Panel opened the application process for Oakland residents interested in serving on the Police Commission. The application due date was June 30, 2017. One hundred and forty-four (144) applications were received by the due date.

In accordance with Measure LL [City Charter Section 604(c)(3)], the Selection Panel had limited time to submit a slate of four regular members and one alternate member to the City Council. The Selection Panel established ad hoc subcommittees that conducted screening interviews of the 144 applicants over the course of multiple days during the weeks of July 10 and 17. **Table 1** provides a summary of the 144 applications during the screening interview process.

Based on the screening interviews, 28 applicants were asked to interview in front of the full Selection Panel. The Selection Panel convened on August 8, 9, 10, and 14 to interview the 28 applicants and conduct deliberations. The Selection Panel sought to make appointments that reflect Oaklanders' diversity of demographic and geographic backgrounds. The panel prioritized candidates who demonstrated a strong commitment to police accountability and public service.

In accordance with the City Charter, the Selection Panel has submitted a slate of four regular members and one alternate member to the City Council as follows:

- 2. As a former OUSD teacher and principal, I've been deeply committed to work on equity in Oakland. I spent 12 years in schools focused on racial and socio-economic equity, often engaging with police officers (both OUSD and OPD) with an emphasis on interrupting systemic oppressions as well as support youth development and as much as possible, stay away from the judicial system. I've had both successful and unsuccessful experiences in attempting to do this with police officers. I also ran a national organization for 5 years (after my time in OUSD) that focused on systemic racial equity transformation in K-12 school districts around the US. In that time, much of our work was building community partnerships with police departments, to help the system deepen its work around racial equity, implicit bias and community policing.

4. 2. Please describe your contacts or experiences with the Oakland Police Department.

As a resident of Oakland since 2000, in both East and West Oakland, I've had multiple personal experiences with police officers. Often, I'd be in an official capacity as a school administrator, sometimes dealing with off site matters. Sometimes, I observe police activity on my streets or in the community, or have had to engage if they've been called to an incident on my block as a witness. Sometimes, police officers have been supportive and mindful. Sometimes, they have been explicitly problematic and demonstrated clear bias or lack of community policing principles. I hope these oversight committee meetings can help create a community support system as well as an accountability system. I've never been one to focus only on punitive, but prefer a system of deep support and development.

- 1. as a police officer *My father was a police officer in NYC. We have deep debate and strong conversations about monitoring police activity, often from a different viewpoint.
- 2. as a criminal prosecutor or defense attorney, *N/A
- 3. with a public agency or nonprofit community group serving or advocating for crime victims or persons charged or convicted of crimes. As an administrator in OUSD, I've had over a decade of multiple interactions

(and built positive relationships) with OPD. Often they were dealing with students that I had a relationship with and we had a mix of positive and negative experiences. In addition, I implemented a Youth Court/Restorative Justice process in our school as an alternative to traditional discipline. In leading this we virtually eliminated suspension of Af-Am males, receiving a visit from the Office of Civil Rights to study what we were doing at our high school as a national model.

Application Page 2, Question 1. "Please describe any life work and significant community volunteer experiences that prepare you to contribute to the work of the Commission."

Born and raised in the Fruitvale neighborhood before moving to San Leandro at age sixteen.

Worked in several warehouses after graduating from San Lorenzo High School in 1966. Member of Communication Workers and Steelworkers Unions.

Student activist attending Chabot College, Hayward, 1969 to 1971. Elected Student Body Vice-President on a Coalition Slate, represented Chabot in the California Community College Student Government Association while agitating for reforms statewide as a member of the Chicano Student Union, including actively supporting the United Farm Workers Union and demonstrating against the Vietnam War.

Married in 1971, raised three children working as a Union Machinist, a non-profit Director, Teamster Warehouser/Shop Steward and Union Carpenter.

Following in my father's footsteps, established my Tax Preparation and Bookkeeping business in 1990 in the Fruitvale, thereby becoming involved in merchant and community issues through several Latino Chambers of Commerce. Actively advocated for grassroots empowerment at City Council and community meetings. Contributed to the early planning of the Fruitvale Transit Village through the Unity Council.

In 1996 the City of Oakland formally adopted Community Policing as City policy, establishing Neighborhood Crime Prevention Councils (NCPCs) citywide. Elected Chair of the Maxwell Park Neighborhood Council (MPNC), Beat 28X, in 1998. Currently serving as such to an eight member Board of Directors that meets monthly including hosting bi-monthly General Assemblies with Neighborhood Action Team (NAT) reports, Crime stats and Guest Speakers on timely topics. In addition, the MPNC has established ten NATs, each with a Chair or Co-Chairs, that act as committees in the areas of Blight and Beautification, Community Building and Diversity, Neighborhood Safety, Education, our Park, First Alarm Private Patrol, Traffic, Cameras, Neighborhood Watch and Communities of Oakland Respond to Emergencies (C.O.R.E.).

In addition to increased safety and quality of life in Maxwell Park, MPNC accomplishments include our upcoming twelfth Annual block party for the entire neighborhood called Day In The Park, our twelve year participation in the Laurel Access to Mills, Maxwell Park and Seminary (LAMMPS) Project that will renovate MacArthur Boulevard from High Street to Seminary, a website (Maxwellparknc.org), two listserves totaling over two thousand neighbors, and ongoing collaboration with many other NCPCs citywide on common issues.

Our understanding of the principles of Community Policing has maintained our consistent focus on the development of a working partnership with OPD and the City of Oakland based on mutual respect.

Appointed by Jean Quan in 2005 to the Measure Y Oversight Committee (Violence Prevention and Public Safety Act of 2004), becoming Chair in 2010, the only original member to serve the ten year term of the Measure.

Elected Treasurer of Oakland's Block By Block Organizing Network (BBBON) in 2010, serving as such to date. As a member of BBBON's Public Safety Committee, participated in City-wide Town Halls, led an OPD/Youth Workshop at a Community Policing Summit and helped arrange a meeting between OPD Chief Batts and Lion Creek Crossing youth among other activities.

Provided security for marches in coordination with OPD during Occupy Oakland. Acted as an Observer of arrests during the second clearing of Occupy Oakland from Frank Ogawa Plaza in November 2011. Promoted the concept of the Peacekeepers, a grassroots, broad, diverse group of Oaklanders acting as monitors of marches and protests, using their moral authority to deter violence against persons or property. Augmented security in coordination with OPD and Private Security after a young man was shot and killed at First Fridays.

Application Page 2, Question 2. "Please describe your contacts or experiences with the Oakland Police Department."

In 2003 and 2004 had various conversations with then Chief Richard Word and the MPNC regarding the specific barriers in OPD culture that prevent effective communication with the community.

Worked with various Problem Solving/Community Resource Officers (PSO/CRO) since 1998 as the Chair of the Maxwell Park Neighborhood Council, Beat 28X. These contacts have met with various degrees of success over the years depending on the degree of commitment to Community Policing of the PSO/CRO. It is notable that this commitment to Community Policing is stronger at the Command Staff level that it is among mid level and line staff, including CRO's and Patrol, that have on occasion exhibited outright resistance to such partnership with the community.

Oakland was profoundly impacted by the deaths of the Fallen Four on March 21, 2009. On several occasions expressed my great disappointment to OPD regarding their not involving the community in their subsequent commemorations of these brave Officers, even after witnessing the outpouring of grief from a broad spectrum of Oaklanders immediately after their murders.

Collaborated with an OPD Captain to hold a youth workshop at a Community Policing Summit in 2011 at which the Captain provided ten Officers, all the materials and extremely valuable insights on the topics covered.

In 2011, upon the return to duty by our CRO Amie Rutten after an on-the-job injury, OPD arranged for the MPNC to deliver Get Well Cards and Chocolates to her as a surprise at an early morning lineup at Eastmont.

In late 2011 during Occupy, OPD allowed myself and three others to observe the arrests in the second clearing of Frank Ogawa Plaza. OPD also coordinated with the Peacekeepers in the marches and protests during that time. Various individuals in OPD have also expressed public and private support for the Peacekeeper concept.

Invited in 2012 by then Chief Howard Jordan to be on an Advisory Panel to his office. Represented the community in the interview process for promotions to Captain in OPD during that year.

Invited over the years to address the Command Staffs of former Chiefs Batts, Jordan and Whent on my perspective on Community Policing and OPD. Developed viable working relationships with OPD Area Four Captains especially as of late.

In early 2014, the Block By Block Organizing Network (BBBON) hosted a panel discussion on Sexually Exploited Minors in Oakland at which OPD provided their nationally recognized expert, Sgt. Holly Joshi.

In 2014, after considerable delay, OPD complied with my request as the Chair of the Measure Y Oversight Committee (Violence Prevention and Public Safety Act of 2004) to provide information on the hours Problem Solving Officers spend in their respective Beats.

Invited by OPD to participate in their Strategic Planning Process from November 2014 to March 2015.

Completed the excellent OPD Citizen's Police Academy (CPA) this month featuring speakers presenting valuable information to participants. Participated in a ride-along in East Oakland this past Saturday that showed the compassion that Officers have for the numerous 5150 calls that they answer, as well as the hard work and danger they face on a daily basis.



Mike A. Nisperos Jr. SUPPLEMENTAL QUESTIONNAIRE

1. Please describe any life work and significant community volunteer experiences that prepare you to contribute to the work of the Commission.

I spent my professional career fairly evenly divided between being a prosecutor, a criminal defense attorney (see 3.b. below) and a public safety policy analyst. As the Director of the Mayor's Office of Drugs and Crimes I pursued an extensive and intensive review of OPD policies and procedures. I reviewed monthly crime statistics and held weekly meetings with Captain in charge of the Criminal Investigation Division. I attended more than a dozen Department of Justice seminars and conferences on "Community Policing" and "Problem Oriented Policing". At he end of 2001 I wrote the Mayor's Public Safety Plan, the centerpiece of which was the evolution of the OPD deployment model from the "Beat 35" (911 response driven) to "Community Policing" (expanded citizen engagement with resource allocation based on data analysis). The City Council adopted the Mayor's plan in 1992 and created a "Community Policing Task Force" to develop specific recommendations for the implementation of the plan. I was assigned to staff the task force under the leadership of Councilmember Wilson Riles, Chair of the Public Safety Committee. I provided Chairman Riles with a proposed syllabus of readings and a list of suggested expert speakers, all of which were accepted. I collected and distributed the written materials and arranged the appearances of the speakers. I wrote the Task Force's final report and presented it to the City Council. The Council adopted same. I monitored the OPD implementation of the Council directive. I routinely attended community meetings to address citizen concerns regarding public safety matters. I served as the Mayor's primary point of contact and official spokesperson for all press matters related to public safety.

I recommended the creation of the Citizens Police Academy and expansion of the Asian Advisory Committee on Crime to further create an African-American Advisory Committee on Crime and a Latino Advisory Committee on Crime. I re-instated and staffed the Mayor's Inter-Agency Council on Drugs and Crime created by Mayor Lionel Wilson.

I acted as the Mayor's budget analyst for the OPD and the Citizens' Police Review Board (CPRB).

In 1997 the City Council sought to expand the jurisdiction and authority of the CPRB and formed a citizen task force to make recommendations accordingly. I staffed the task force and scribed the final report. I presented the report and the Council adopted it. I was selected to be the new director. I wrote the administrative manual for the CPRB, added additional staffing and conducted internal training on complaint intake, investigation and presentation to the Board. I served as principal negotiator, on behalf of the City Manager, with the Oakland Police Officers Association for all MOU matters concerning the CPRB. In preparation I thoroughly familiarized myself with the Police Officers Bill of Rights (Gov. Code Sec 3300 et seq). I established regular staff meetings with CPRB and the Internal Affairs Unit,

which lead to greater exchange of relevant information and formal approval by the Chief of Police for the mutual exchange of citizen complaints.

2. Please describe your contacts or experiences with the Oakland Police Department.

I have been arrested four times by the Oakland Police Department. Three cases were never charged. The one case that was charged was subsequently dismissed.

As a Deputy DA, Director of the Mayor's Office of Drugs and Crime and Director of the CPRB I have gone on more than 50 full shift ride-a-longs with OPD. I taught the class on Officer Rights before the CPRB as part of the OPD Academy curriculum.

As a prosecutor and defense attorney I had routine contact with OPD officers as witnesses or experts. As a prosecutor I often assisted officers with preparation of search warrants and line-ups. As a defense attorney I routinely accompanied clients to file complaints with Internal Affairs.

I began my professional career as a Deputy District Attorney assigned to the Oakland Municipal Court. I left the office to start a solo practice focusing on criminal defense. I left that practice to be commissioned as a USAF JAG Officer. I was assigned to two different Strategic Air Command bases, Andersen AFB (Guam) and March AFB (Riverside, CA). At both bases I was initially designated the Chief of Military Justice (base prosecutor). At both bases I successfully requested reassignment as the Area Defense Counsel (base public defender). After leaving the USAF I worked as an USDOJ/INS Trial Attorney prosecuting deportation cases before the San Francisco Immigration Courts. My caseload was primarily deportation cases predicated on criminal convictions.

As an associate in the Law Offices of John Burris my primary duties were intake case evaluation and criminal trials. Many cases involved claims of police misconduct. We also represented Oakland police officers. I acted as co-counsel in a case where two police officers were charged with perjury for statements given during a deposition for a separate civil rights case the officers had filed against the Oakland Police Department. I served as second chair in the defense of an Oakland jailer tried for conspiracy to aid in the escape of a federal prisoner. I also served as an associate in

the Law Offices of A. Brent Carruth. The sole area of practice was criminal defense. I handled cases from preliminary examination through jury trial.

After retiring from the PERS system I accepted an Assistant Attorney General position in Commonwealth of the Northern Mariana Islands (CNMI), a part of the United States by covenant. My charge there was to establish and then supervise a Government Corruption/White Collar Crime Unit. I developed internal administrative procedures and also obtained outside funding for two attorney and two investigator positions. I left the CNMI, after several successful prosecutions, to accept the position of Director, Public Defender Service Corporation for the Territory of Guam. As the "Chief Public Defender" I managed a team of attorneys, investigators and support staff to provide legal representation for indigent defendants in criminal cases.

Both of my children began their professional careers as prosecutors. My daughter served as a Deputy District Attorney in Solano County for ten years. My son served as a Deputy District Attorney in Contra Costa County for three years. Both are now in private practice focusing on criminal defense.

WHEREAS, after the City Council confirms the Selection Panel's slate of appointees to the Police Commission, Section 604(c)(6) requires the Selection Panel to determine the terms of the first group of Commissioners in order to effect a staggering of terms; now therefore, be it

RESOLVED, That pursuant to City Charter Section 604(c)(3), the City Council hereby accepts the Selection Panel slate in its entirety to serve as members of the Police Commission as follows:
