RECOMMENDATION

Council President Reid Recommends The City Council Approve The Proposed 2018 Schedule of City Council And Council Committee Meetings And An Associated Agenda and Report Distribution Schedule.

BACKGROUND / LEGISLATIVE HISTORY

The Brown Act requires each legislative body of a local agency provide, by ordinance, resolution, bylaws, or by whatever other rule is required for the conduct of business by that body, the time and place for holding regular meetings.

Rule 7 of the City Council's Rules of Procedure (Resolution 86034 C.M.S) requires that City Council meetings are held on the first and third Tuesdays of every month. Fifth Tuesdays are utilized for Special Meetings and workshops. Rule 4 of the Council's Rules of Procedures requires that Council Standing Committees are held on the second and fourth Tuesdays of every month. Additionally, Rule 20 requires that August 1 through August 31 is the City Council's Annual Recess. The proposed schedule is prepared for consideration and approval by the City Council and establishes the proposed meeting dates for conduct of business.

EXPLANATION OF SCHEDULE:

A. Spring Recess

The City Council will cancel meetings the week of April 2, 2018 through April 6, 2018 to align with the Spring Recess for Peralta Community Colleges and the Oakland Unified School District.

B. Summer Recess

The proposed dates for Council 's Summer Recess provide for completion of the legislative session following a Council meeting to prevent holdover of legislative matters holdover from Council Committee meetings. The proposed further schedule anticipates mid-cycle budget activity and targets completion of the legislative year at completion of the City Council meeting of July 17, 2018.

C. Election Day

The City Council will not meet on Election day.

D. Thanksgiving Recess

The City Council will cancel all meetings during the week of Thanksgiving. The proposed dates for Council's Thanksgiving Recess will be Monday, November 20 through Friday, November 24, 2018.

E. Winter Recess

The City Council and Council Committee meetings will be cancelled during the last two weeks of the year for Winter Recess. The proposed dates for Council's Winter Recess will be Monday, December 18 through Friday, December 31, 2018.

RECOMMENDED CHANGES

Council's Rules of Procedures provide for committee review of legislative matters, except when the Rules Committee has authorized direct scheduling to Council and/or the Council President, Mayor, City Administrator, or their Council Members in accordance with relevant law call for a special meeting.

To ensure fidelity with the Council Committee review of legislative matters as prescribed in the Council's Rules of Procedures, Resolution 86034 C.M.S., the proposed adjustments are recommended to address holidays that would impact regular legislative flow.

A. Cancellation of the City Council Meeting of January, 2nd 2018

The Council President recommends the City Council meeting of January 2, 2018 and the Rules & Legislation Committee meeting of January 4, 2018 be cancelled as the Council has concluded the 2017 year with a City Council meeting.

- C. Schedule Special Council Meeting for Monday, September 17th, 2018
- D. Cancel Council Meeting for Tuesday, September 18th, 2018 in Observance of Yom Kippur

The Council President recommends the City Council meeting of September 5th, 2017 and the Rules & Legislation Committee meeting of September 7th, 2017 be cancelled as it is the week after Labor Day.
