Subject: RESOLUTION AUTHORIZING AND APPROVING

SETTLEMENT OF THE CITY'S LAWSUIT AGAINST

DEFENDANTS MBIA INC., MBIA INSURANCE CORPORATION, NATIONAL PUBLIC FINANCE GUARANTEE CORPORATION, AND JASON KISSANE (COLLECTIVELY, "MBIA") IN THE AMBAC BOND INSURANCE CASES FOR MBIA'S PAYMENT

OF \$50,000

Dear President Reid and Members of the City Council:

This resolution authorizes and approves settlement of the City's lawsuit against defendants MBIA Inc., MBIA Insurance Corporation, National Public Finance Guarantee Corporation, and Jason Kissane (collectively, "MBIA")") in *Ambac Bond Insurance Cases*, JCCP 4555, San Francisco Superior Court Case No. CJC-08-004555 (City of Oakland v. Ambac Financial Group, Inc., et al., San Francisco Superior Court Case No. CGC-08-479241). Defendant MBIA will pay the City \$50,000 under the settlement agreement and be dismissed from the litigation.

To date, City has received \$690,599.42 from settlements with other defendants. In 2008, the City filed this lawsuit against various bond insurers who conspired with each other and with the major credit rating agencies to maintain a dual rating system that unfairly rated pending municipal bond issuances lower than corporate bonds. This conspiracy violated the antitrust laws and forced Oakland and other municipalities to purchase bond insurance as a credit enhancement in order to issue bonds without having to offer extremely high interest rates. As a result of the conspiracy, the City suffered hundred of thousands of dollars in damages because it had to pay higher rates for bond insurance.

The complaint also alleges claims for fraud and breach of contract against two of the bond insurers, Syncora Guarantee, Inc. (f/k/a XL Capital Assurance, Inc.) and

Ambac,¹ alleging that they failed to disclose their exposure to risky subprime debt and other financial instruments which caused the City's interest payments on its auction rate securities to spike and forced the City to engage in costly refundings of those issuances.

As noted above, MBIA will pay the City \$50,000 in exchange for dismissal by the City of Oakland. After the deduction of fees and costs, Oakland's estimated *net* recovery from the MBIA settlement will be approximately \$37,836.19.

This settlement proposal will be presented to the Council in closed session on December 12, 2017. The resolution authorizes the City Attorney to execute a settlement agreement consistent with the terms of the settlement proposal.

We recommend that the City Council adopt the resolution.
