RECOMMENDATION

Staff Recommends That The City Council Amend Resolution No. 86490 C.M.S. Which Authorized The City Administrator, Or Her Designee, Among Other Things, To Enter Into An Agreement To Accept, Appropriate And Administer FY 2016 Urban Search And Rescue (US&R) Grant Funds, To Accept, Appropriate And Administer Supplemental Fiscal Year (FY) 2016 US&R Grant Funds In An Amount Not To Exceed One Hundred Sixteen Thousand Nine Hundred And Eleven Dollars (\$116,911) For A Cumulative FY 2016 US&R Grant Award Allocation In An Amount Not To Exceed One Million Three Hundred And Eighty-Six Thousand Four Hundred And Ninety-Three Dollars (\$1,386,493) And Appropriate Said Funds To The US&R Task Force.

EXECUTIVE SUMMARY

On November 29, 2016, City Council adopted Resolution No. 86490 C.M.S. authorizing the City Administrator, on behalf of the City of Oakland, to accept up to one million two hundred sixtynine thousand five hundred eighty-two dollars (\$1,269,582) in Fiscal Year (FY) 2016 US&R grant funds (Attachment A).

In September 2017, the US&R Task Force received notice they would be receiving an amendment of supplemental funding in the amount of \$46,901 to the initial award and an additional 2nd amendment providing an amount of \$70,010, totaling one hundred sixteen thousand nine hundred and eleven dollars (\$116,911) to be used for the purchase of specific communications equipment (Attachment B). Adoption of the amended resolution will enable the City to accept, appropriate and administer the supplemental funding.

BACKGROUND / LEGISLATIVE HISTORY

The City of Oakland is the Sponsoring Agency for a FEMA Urban Search and Rescue Task Force, California Task Force 4 (CA-TF4). Federal funds are provided to the elite US&R task forces to have a response system that provides for the coordination, development, and maintenance of effort to locate, extricate, and provide immediate medical treatment to victims trapped in collapsed structures, and to conduct other lifesaving operations. the US&R Cooperative Agreement has increased from prior years to provide the FEMA Task Forces with improved capabilities in water operations and in rescues conducted in an area contaminated with hazardous waste and materials.

On November 29, 2016, City Council adopted Resolution No. 86490 C.M.S. authorizing the City Administrator, on behalf of the City of Oakland, to accept up to one million two hundred sixtynine thousand five hundred eighty-two dollars (\$1,269,582) in FY 2016 US&R grant funds for the September 1, 2016 to August 31, 2019 grant period. Staff recommends that the City Council amend Resolution No. 86490 C.M.S. to accept FY 2016 US&R supplemental grant funding in an amount not to exceed one hundred sixteen thousand nine hundred and eleven dollars (\$116,911), which will make the cumulative FY 2016 US&R grant award allocation one million three hundred and eighty-six thousand four hundred and ninety-three dollars (\$1,386,493).

ANALYSIS AND POLICY ALTERNATIVES

This grant will continue to have a positive impact for the City of Oakland. The members of the Task Force are members of the Oakland Fire Department and other participating fire agencies, and they receive training for response to man-made and natural disasters. The training provides knowledge, skills, and abilities to a network of local first responders so they can perform search and rescue operations, victim extrication, and patient treatment to reduce loss of life as the result of emergency incidents in the City and region. In addition, the fire service has learned that the sharing of services and resources is the most economical path, and participating in the US&R system is but one example of this in action.

FISCAL IMPACT

Approval of this resolution will authorize the acceptance and appropriation of supplemental FY 2016 US&R funds, bringing the total grant award to one million three hundred and eighty-six thousand four hundred and ninety-three dollars (\$1,386,493).

The FEMA US&R Task Force preparedness cooperative agreement grant, including supplemental funding, is in the amount of one million three hundred and eighty-six thousand four hundred and ninety-three dollars (\$1,386,493) for staff, facility lease and maintenance, disaster response and preparedness training, personnel and equipment.

Social Equity: The FEMA US&R Cooperative Agreement provides the City of Oakland Fire Department with access to training and equipment needed for Technical Rescues, Structural Collapse, and Disaster Response, which represents a significant enhancement of the local capabilities in the event of a local incident, such as an earthquake, and benefits all the people of Oakland.

RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR, OR HER DESIGNEE TO: A) ENTER INTO A GRANT COOPERATIVE AGREEMENT WITH THE FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) TO ACCEPT AND APPROPRIATE FEDERAL (FEMA) FUNDS FOR THE PERIOD SEPTEMBER 1, 2016 TO AUGUST 31, 2019, IN THE AMOUNT OF ONE MILLION TWO HUNDRED SIXTY NINE THOUSAND FIVE HUNDRED EIGHTY TWO DOLLARS (\$1,269,582) TO MEET CONTINUING MANAGEMENT, TRAINING AND EQUIPMENT NEEDS OF THE FIRE DEPARTMENT'S URBAN SEARCH AND RESCUE (US&R) TASK FORCE; B) EXPEND THE FEMA FUNDS IN ACCORDANCE WITH THE PRELIMINARY SPENDING PLAN WITHOUT FURTHER COUNCIL APPROVAL, INCLUDING THE PURCHASE OF EQUIPMENT FROM SERVICES **ADMINISTRATION** AND OTHER GENERAL GOVERNMENT REQUIRED PRICING SCHEDULES; C) WAIVING THE CITY'S ADVERTISING AND COMPETITIVE BIDDING AND **PURCHASING** REQUIREMENTS FOR **PROCUREMENT** EOUIPMENT WHEN REQUIRED BY THE GRANTOR; D) APPROVE TRAVEL FOR CITY PERSONNEL FOR THE FEMA COOPERATIVE AGREEMENT PROGRAM ON SHORT NOTICE; E) APPROVE A CONTRIBUTION FROM THE GENERAL PURPOSE FUND (GPF) IN TO THE INFORMATION **AMOUNT EQUIVALENT** AN TECHNOLOGY DEPARTMENT (ITD) -INTERNAL SERVICE FUND (ISF) CHARGES AFFILIATED WITH SAID GRANT, ESTIMATED AT SIX THOUSAND SEVEN HUNDRED AND FOUR DOLLARS (\$6,704.00) FOR FISCAL YEAR 2016-17, AND TO PROVIDE A CONTRIBUTION EQUIVALENT TO THE ITD-ISF CHARGE FOR THE DURATION OF THE GRANT PERIOD

WHEREAS, the Oakland Fire Department is the Sponsoring Agency for California Task Force Four (CA-TF4), an Urban Search and Rescue (US&R) Task Force, which includes members of sixteen (16) Local Participating Fire Agencies including: Alameda Fire Department, Alameda County Fire Department, Berkeley Fire Department, Central Fire Authority of Sonoma County, Contra Costa County Fire Protection District, Fremont Fire Department, Hayward Fire Department, Livermore Pleasanton Fire Department, Marin County Fire Department, Monterey County Regional Fire District, Moraga-Orinda Fire

District, Novato Fire Protection District, Parks Reserve Forces, Salinas Fire Department, San Ramon Valley Fire Protection District, Santa Rosa Fire Department; and

WHEREAS, CA-TF4 is one of eight (8) California and twenty-eight (28) national US&R teams trained and equipped to respond to natural disasters and weapons of mass destruction (WMD) events; and

WHEREAS, the Federal Emergency Management Agency (FEMA), a component of the Department of Homeland Security (DHS), is the federal management agency; and

WHEREAS, FEMA supports all twenty-eight (28) US&R teams with federal cooperative agreements; and

WHEREAS, CA-TF4 is eligible to apply for a FEMA preparedness cooperative agreement program grant in the amount of one million two hundred twenty nine thousand five hundred eighty two dollars (\$1,269,582) for disaster response and operational readiness, preparedness training, personnel and equipment; and

WHEREAS, FEMA has approved this funding to support the following positions:

1.00 FTE	Program Coordinator		
1.00 FTE	Warehouse Specialist		
1.50 FTE	Student Trainees, PT		

WHEREAS, the coding block is Federal Emergency Management Agency (FEMA) Fund (2124), Special Operation Division (20815), Special Operation Program (PS18), in various accounts and a project to be determined, and the revenue received from this grant, including reimbursement from training courses, will be deposited to same fund, organization, project, program and the FEMA Grants Revenue account (46129); and

WHEREAS, this FEMA Program Grant requires the City to provide training to members of CA-TF4, respond as requested to Local, State and National Incidents, and to procure and store equipment as directed by FEMA; and

WHEREAS, Oakland Municipal Code Section 2.04.050.I.5 permits the City Council to waive the City's advertising, bidding, and purchasing requirements upon a finding that it is in the best interests of the City to do so; and

WHEREAS, when necessary this FEMA program grant requires the City to purchase equipment from various General Service Administration Agency (GSA) and/or other Governmental Purchasing Schedules in order to maintain consistency in training and equipment among the jurisdictions participating in the state and national US&R Teams; and

WHEREAS, staff recommends that it is in the best interests of the City to waive the City's advertising, bidding, and purchasing requirements for the purchase of equipment with the FEMA grant funds so that the City can receive the full FEMA grant funding

amount and be in compliance with the procurement lists of the General Services Administration and other related government pricing schedules; and

WHEREAS, the City requires the Fire Chief and City Administrator to obtain Council approval for the payment of travel expenses for Fire Department personnel in advance, and this FEMA program grant requires the City to send Oakland Fire Department firefighters and other personnel from other jurisdictions to do FEMA required business, training or response activities on short notice; and

WHEREAS, CA-TF4 is not based in a facility owned, managed or maintained by the City of Oakland, does not utilize City owned vehicles or fleet services, but instead uses facilities, vehicles and other resources that are owned or leased by the federal government; and

WHEREAS, the only City resources utilized by the CA-TF4 pertain to information technology; and

WHEREAS, it is the determination of the grantor that the payment of Information Technology Department (ITD)-Internal Service Fund (ISF) charges are not reimbursable by the grant; and

WHEREAS, the Fire Department is requesting a contribution from the General Purpose Fund to offset the cost of the Department's ITD-ISF charges, estimated to be six thousand seven hundred and four dollars (\$6,704.00) for FY 2016-17, and to provide a contribution equivalent to the ITD-ISF charge for the duration of the grant period because said charges are not payable by this grant; and

WHEREAS, CA-TF4 is available to the City of Oakland in the event of an attack within the City or surrounding communities or occurrence of a local natural disaster; now, therefore, be it

RESOLVED, that the City Administrator or her designee is authorized to enter into a grant cooperative agreement with the FEMA to accept and appropriate federal funds (FEMA grant funds) for the Oakland Fire Department for the period September 1, 2016 to August 31, 2019, in the amount not to exceed one million two hundred sixty nine thousand five hundred eighty two dollars (\$1,269,582) to meet continuing management, training and equipment needs of the Fire Department's US&R Task Force; and

FURTHER RESOLVED, that the City Administrator or her designee is authorized to accept and appropriate said FY 2016 US&R Grant funds up to one million two hundred sixty nine thousand five hundred eighty two dollars (\$1,269,582) into FEMA Fund (2124), Special Operation Division (20815), Special Operation Program (PS18), in various accounts and a project to be determined; and be it

FURTHER RESOLVED, that a contribution from the GPF in an amount equivalent to the project's ITD-ISF charges shall be appropriated into FEMA Fund (2124), Special Operations Division (20815), Information Technology Account (56111), a project

number to be determined, Special Operation Program, estimated in the amount of six thousand seven hundred and four dollars (\$6,704.00) for FY 2016-17, and that a contribution from the GPF equivalent to the ITD-ISF charges shall be appropriated into the FEMA Fund (2124), Special Operations Division (20815), Information Technology Account (56111), a project number to be determined, Special Operation Program for the duration of the grant period; and be it

FURTHER RESOLVED, that the City administrator or her designee is authorized to expend the FEMA grant funds in accordance with the preliminary spending plan without further council approval, including funding for training and the purchase of equipment as required by the General Services Administration (GSA) and other government pricing schedules to support the US&R task force's response capability as required by FEMA; and, be it

FURTHER RESOLVED, that, pursuant to Oakland Municipal Code Title 2, Chapter 2.04, Section 2.04.050.I.5 and reasons stated in the agenda report accompanying this Resolution and above, the City Council hereby finds that it is in the best interests of the City to waive Oakland's competitive bidding requirements for the purchase of equipment needed for the CA-TF4 US&R team; and, be it

FURTHER RESOLVED, that the City Council hereby authorizes the City Administrator or her designee to expend the FEMA grant funds in accordance with the preliminary spending plan, including funding for training and the purchase of equipment needed for the US&R team from the General Service Administration Agency (GSA) and/or other Governmental Purchasing Schedules without return to Council; and, be it

FURTHER RESOLVED, that the City Council finds that pursuant to Oakland Municipal Code Section 2.04.050.I.5, for the reasons stated above and in the agenda report accompanying this resolution, that it is in the best interests of the City to waive the advertising and bidding requirements for the purchase of equipment needed for the CA-TF4 US&R team training when such purchases and services are required by FEMA to be selected from the General Services Administration and other government procurement lists, and so waives such requirements; and, be it

FURTHER RESOLVED, that the City Council hereby authorizes the City Administrator, for timeliness and security reasons, to authorize City personnel participating in the FEMA cooperative agreement program to travel on short notice per FEMA directives without return to Council; and, be it

FURTHER RESOLVED, that all contracts issued hereunder shall be reviewed and approved by the office of the City Attorney for form and legality and copies shall be placed on file in the Office of the City Clerk.

INTRODUCED BY COUNCILMEMBER

STAFF RECOMMENDS THAT THE CITY COUNCIL AMEND RESOLUTION 86490 NO. C.M.S. WHICH AUTHORIZED THE CITY ADMINISTRATOR, OR HER DESIGNEE, AMONG OTHER THINGS, TO ENTER INTO AN AGREEMENT TO ACCEPT, APPROPRIATE AND ADMINISTER FY 2016 URBAN SEARCH AND RESCUE (US&R) GRANT FUNDS, TO ACCEPT, APPROPRIATE AND ADMINISTER SUPPLEMENTAL FISCAL YEAR (FY) 2016 US&R GRANT FUNDS IN AN AMOUNT NOT TO EXCEED ONE HUNDRED SIXTEEN THOUSAND NINE HUNDRED AND ELEVEN DOLLARS (\$116,911) FOR A CUMULATIVE FY 2016 US&R GRANT AWARD ALLOCATION IN AN AMOUNT NOT TO EXCEED ONE MILLION THREE HUNDRED AND EIGHTY-SIX THOUSAND FOUR HUNDRED AND NINETY-THREE DOLLARS (\$1,386,493) AND APPROPRIATE SAID FUNDS TO THE US&R TASK FORCE

WHEREAS, the Oakland Fire Department is the Sponsoring Agency for California Task Force Four (CA-TF4), an Urban Search and Rescue (US&R) Task Force, which includes members of 16 Local Participating Fire Agencies including: Alameda Fire Department, Alameda County Fire Department, Berkeley Fire Department, Central Fire Authority of Sonoma County, Contra Costa County Fire Protection District, Fremont Fire Department, Hayward Fire Department, Livermore Pleasanton Fire Department, Marin County Fire Department, Monterey County Regional Fire District, Moraga-Orinda Fire District, Novato Fire Protection District, Parks Reserve Forces, Salinas Fire Department, San Ramon Valley Fire Protection District, Santa Rosa Fire Department; and

WHEREAS, CA-TF4 is one of 8 California and 28 national US&R teams trained and equipped to respond to natural disasters and weapons of mass destruction (WMD) events; and

WHEREAS, the Federal Emergency Management Agency (FEMA), a component of the Department of Homeland Security (DHS), administers this grant; and

WHEREAS, FEMA supports all 28 US&R teams with federal cooperative agreements; and

WHEREAS, on November 29, City Council adopted Resolution No. 86490 C.M.S. authorizing the City Administrator, on behalf of the City of Oakland, to accept up to \$1,269,582 in fiscal year (FY) 2016 US&R grant funds; and

WHEREAS, CA-TF4 is eligible to apply for funding to supplement their FY 2016 US&R Grant; and

WHEREAS, CA-TF4 was notified by FEMA that they had been awarded one hundred sixteen thousand nine hundred and eleven dollars (\$116,911) in supplemental funding to be used for the purchase of communications equipment; and

WHEREAS, the coding blocks for this grant are: FEMA Fund (2124), Special Operation Division (20815) and Budget and Fiscal Division (20521), Special Operation Program (PS18), various projects, award and accounts, the US&R 2016 Supplemental Grant A Project (103908) and the US&R 2016 Supplemental Grant B Project (1003976); and

WHEREAS, the Fire Department is requesting an amendment to Resolution No. 86490 C.M.S. due to an increased grant funding allocation in an amount not to exceed one hundred sixteen thousand nine hundred and eleven dollars (\$116,911) for a cumulative FY 2016 US&R grant award allocation in an amount not to exceed one million three hundred and eighty-six thousand four hundred and ninety-three dollars (\$1,386,493) and appropriate said funds to the US&R Task Force; and it; and

WHEREAS, when necessary this FEMA program grant requires the City to purchase equipment from various General Service Administration Agency (GSA) and/or other Governmental Purchasing Schedules in order to maintain consistency in training and equipment among the jurisdictions participating in the state and national US&R Teams; and

WHEREAS, CA-TF4 is available to the City of Oakland in the event of an emergency or occurrence of a local natural disaster within the City or surrounding communities; now, therefore, be it

RESOLVED: that the City Administrator, or her designee, is authorized to accept, appropriate and administer supplemental FY 2016 US&R supplemental grant funds in an amount not to exceed one hundred sixteen thousand nine hundred and eleven dollars (\$116,911) for a cumulative FY 2016 US&R grant award allocation in an amount not to exceed one million three hundred and eighty-six thousand four hundred and ninety-three dollars (\$1,386,493) and appropriate said funds to the US&R Task Force; and be it

FURTHER RESOLVED: that the City administrator is authorized to expend the FEMA grant funds in accordance with the preliminary spending plan without further council approval, including funding for training and the purchase of equipment as required by the federal General Services Administration Agency (GSA) and other government pricing schedules to support the US&R Task Force's response capabilities as required by FEMA; and be it

FURTHER RESOLVED: Revenues and appropriations will be allocated to the FEMA Fund (2124), Special Operation Division (20815) and Budget and Fiscal Division, Special Operation Program (PS18), various projects, award and accounts, and the US&R 2016 Supplemental Grant A Project (103908), and the US&R 2016 Supplemental Grant B Project (1003976); and, be it

FURTHER RESOLVED: That all contracts issued hereunder shall be reviewed and approved by the office of the City Attorney for form and legality and copies shall be placed on file in the Office of the City Clerk.
