RESOLUTION AUTHORIZING AND DIRECTING THE CITY ATTORNEY TO COMPROMISE AND SETTLE THE RELATED CASES: (1) CHINWE OLIKE, ET AL. V. CITY OF OAKLAND, ET AL., ALAMEDA COUNTY SUPERIOR COURT NO. RG16810453 IN THE AMOUNT OF TEN THOUSAND DOLLARS AND NO CENTS (\$10,000.00) AND (2) UNITED FINANCIAL CASUALTY CO. V. CITY OF OAKLAND, ALAMEDA COUNTY SUPERIOR COURT, CASE NO. RG17854117 IN THE AMOUNT OF THIRTY SIX THOUSAND, ONE HUNDRED AND FIFTEEN DOLLARS AND FIFTY TWO (\$36,115.52), FOR A TOTAL SETTLEMENT AMOUNT OF FORTY-SIX THOUSAND, ONE HUNDRED AND FIFTEEN DOLLARS AND FIFTEEN CENTS (\$46,115.52), AS A RESULT OF AN AUTO COLLISION ON MAY 21, 2015 (OAKLAND POLICE DEPARTMENT- AUTO COLLISION)

WHEREAS, Chinwe Olike, Ogenna Udemezue and Oakland Police Officer Anthonine Jones were involved in an auto collision at the intersection of 17th & Castro Streets in Oakland on February 13, 2015; and

WHEREAS, Ms. Chinwe Olike and Ogenna Udemezue allegedly suffered damage to their car and sustained injuries requiring medical treatment, as a result of this accident; and

WHEREAS, Ms. Chinwe Olike's property damage was paid by her insurance, represented by United Financial Casualty Co.; and

WHEREAS, Alameda County Superior Court Actions RG16810453 and RG17854117 were filed against the City of Oakland alleging negligence; and

WHEREAS, without admitting fault or wrongdoing, the City has determined to compromise and settle Ms. Chinwe Olike and Ogenna Udemezue's claim against it for the sum of Ten Thousand Dollars and No Cents (\$10,000.00); and

WHEREAS, without admitting fault or wrongdoing, the City has determined to compromise and settle United Financial Casualty Co.'s claim against it for the sum of Thirty Six, Thousand, One Hundred and Fifteen Thousand Dollars and Fifty Two Cents (\$36,115.52); now therefore, be it

RESOLVED: That the City Attorney is authorized and directed to compromise and settle the case of Chinwe Olike, et al. v. City of Oakland, et al., Alameda County Superior Court No. RG16810453 for the sum of Ten Thousand Dollars and No Cents (\$10,000.00), and the related case of United Financial Casualty Co. v. City of Oakland, Alameda County Superior Court, Case No. RG17854117, for the sum of Thirty Six, Thousand, One Hundred and Fifteen Dollars and Fifty Two Cents (\$36,115.52); and be it

FURTHER RESOLVED: That the City Attorney is further authorized and directed to take whatever steps as may be necessary to effect said settlement.
