OAKLAND CITY COUNCIL RESOLUTION NO. 87096 - C.M.S.

INTRODUCED BY COUNCILMEMBER LYNETTE GIBSON MCELHANEY

RESOLUTION AUTHORIZING A GRANT NOT TO EXCEED \$1,000 FROM COUNCILMEMBER MCELHANEY'S GRAFFITI ABATEMENT MURAL AND GREEN WALL FUNDS TO THE OAKLAND PARKS AND RECREATION FOUNDATION FOR THE ADAMS POINT NEIGHBORHOOD GROUP'S MOSAIC TRASH CONTAINER PROJECT

WHEREAS, on June 27, 2013, the City Council adopted a budget that set aside Graffiti Abatement funds for Murals and Green Walls for councilmembers to grant to address graffiti within their districts; and

WHEREAS, the Adams Point Neighborhood Group through their fiscal sponsor the Oakland Parks and Recreation Foundation plans to install mosaics on the trash containers on the thoroughfares surrounding the Adams Point neighborhood, specifically grand Avenue, Harrison Street, MacArthur Boulevard and the entrance to the Gardens at Lakeside Park, as the trash containers are currently in a state of neglect and have been damaged or marred by vandalism; and

WHEREAS, Councilmember McElhaney wishes to grant a portion of her Graffiti Abatement Mural and Green Wall Funds to the Adams Point Neighborhood Group for upkeep of their trashcan mosaic project to deter graffiti and blight; and

WHEREAS, both the Adams Point Neighborhood group and the Oakland Parks and Recreation Foundation are well-known community organizations with long-standing histories of improving the quality of life for residents of Adams Point; and

WHEREAS, in conformance with City requirements, the Oakland Parks and Recreation Foundation will provide documentation for the use of the Councilmember's Graffiti Abatement Mural and Green Wall funds; now, therefore, be it

RESOLVED: That the City Council authorizes a grant of \$1,000 from Councilmember Lynette Gibson McElhaney's Graffiti Abatement Mural and Green Wall funds to the Oakland Parks and Recreation Foundation for the Adams Point Neighborhood Group's trash container mosaic project; and be it **FURTHER RESOLVED:** That the City Administrator is authorized to execute a grant agreement in an amount not to exceed \$1,000 with the Oakland Parks and Recreation Foundation for the above purpose, subject to approval as to form and legality by the City Attorney.
