OAKLAND CITY COUNCIL RESOLUTION NO. 87120 C.M.S.

INTRODUCED BY COUNCILMEMBER DAN KALB

RESOLUTION AUTHORIZING COUNCILMEMBER DAN KALB TO TRAVEL TO SACRAMENTO, CALIFORNIA TO ATTEND THE LEAGUE OF CALIFORNIA CITIES' HOUSING AND COMMUNITY DEVELOPMENT COMMITTEE MEETINGS ON JANUARY 19, 2018 AND APRIL 13, 2018, AND BE REIMBURSED FOR NECESSARY EXPENSES

WHEREAS, Councilmember Dan Kalb, an appointed Delegate to the League of California Cities and member of the League's Housing and Community Development Committee, attended the Committee's meeting in Sacramento, CA on January 19, 2018 and is planning on traveling to Pomona, CA on April 12, 2018 to attend the Committee's meeting on April 13, 2017 2018; and

WHEREAS, City Council Resolution No. 82800 C.M.S. approved by the Council on June 1, 2010 requires that, when Councilmembers seek Council approval for using City funds for travel, their agenda materials shall indicate whether travel involves airline transportation and lodging and shall provide an estimate of the cost of airline, lodging, per diem and conference fees and the source of City funding that will be used to cover the travel costs; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the cost for Councilmember Kalb on January 19 was \$108 for mileage reimbursement and parking and the estimated cost for Councilmember Kalb on April 12-13 is up to \$195 for one night of lodging, up to \$112 for two days of per diem, and up to \$350 for air fare; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the source of City funding that will be used to cover the travel costs will be the City Council Contingency Project funds; and

WHEREAS, Councilmember Dan Kalb seeks City Council approval of the aforementioned estimated costs to travel to Sacramento, CA and Pomona, CA to attend the League of California Cities' Housing and Community Development Committee meetings; now, therefore, be it

RESOLVED: That all expenses incurred for said travel are hereby authorized.
