RESOLUTION: 1) AUTHORIZING THE CITY ADMINISTRATOR TO CONTRACT **MISSION** AWARD TO LINEN SUPPLY, CORPORATATION, THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER TO PROVIDE UNIFORM AND LAUNDRY SERVICES IN THE ANNUAL AMOUNT NOT-TO-EXCEED FIVE HUNDRED FOUR THOUSAND TWO HUNDRED THIRTY-EIGHT DOLLORS (\$504.238.00) PER YEAR FOR A THREE (3) YEAR TERM, JUNE 1, 2018 TO MAY 31, 2021, FOR A TOTAL CONTRACT AMOUNT FOR THE INITIAL THREE YEAR TERM OF ONE MILLION FIVE HUNDRED TWELVE THOUSAND SEVEN HUNDRED FOURTEEN DOLLARS (\$1,512,714.00); AND 2) **AUTHORIZING THE CITY ADMINISTRATOR TO EXECUTE TWO (2)** ADDITIONAL ONE YEAR AGREEMENT EXTENSIONS UNDER THE SAME TERMS, CONDITONS AND PRICING FOR AN AMOUNT OF FIVE HUNDRED FOUR THOUSAND TWO HUNDRED THIRTY-EIGHT DOLLARS (\$504,238.00) PER YEAR, FOR A TOTAL NOT-TO-EXCEED AMOUNT OF TWO MILLION FIVE HUNDRED TWENTY-ONE THOUSAND ONE HUNDRED NINETY DOLLARS (\$2,521,190.00) FOR A TERM OF FIVE (5) YEARS WITHOUT RETURNING TO COUNCIL UPON A DETERMINATION BY THE CITY ADMINISTRATOR THAT THE CONTRACTOR IS PROVIDING SATISFACTORY PERFORMANCE

WHEREAS, on September 28, 2017 in accordance with Oakland Municipal Code (OMC) 2.04.050 the City issued and advertised Specification No. 18-954-00/RFQ 64443 to provide Uniform and Laundry Services; and

WHEREAS, on October 25, 2017 the City Clerk received two bids in response to Specification No. 18-954-00/RFQ 64443; and

WHEREAS, the bid submitted by Mission Linen Supply was evaluated and deemed the lowest responsive and responsible bidder and meets all the requirements contained in Specification No. 17-550-00/ RFQ 34411 to provide Uniform and Laundry Services; and

WHEREAS, all proposed contract expenditure allocations shall be expensed to various departments citywide and contingent upon the availability of funding; now, therefore be it

RESOLVED: That a contract be awarded to Mission Linen Supply, a corporation, the lowest responsive and responsible bidder, a non-local business enterprise, in the annual amount not-to-exceed five hundred four thousand two hundred thirty-eight dollars (\$504,238.00) per year for a three (3) year term, June 1, 2018 to May 31, 2021 for citywide uniform and laundry services, for a total contract amount for the initial three year term of one million five hundred twelve thousand seven hundred fourteen dollars (\$1,512,714.00); and be it

FURTHER RESOLVED: That the City Administrator is authorized to execute two (2) additional one year agreement extensions for an amount of five hundred four thousand two hundred thirty-eight dollars (\$504,238.00) per year, under the same terms, conditions and prices, for a total not-to-exceed amount of two million five hundred twenty-one thousand one hundred ninety dollars (\$2,521,190.00) for a term of five (5) years without returning to council upon a determination by the City Administrator that the contractor is has and continues to provide satisfactory performance; and be it

FURTHER RESOLVED: That the City Council hereby rejects all other bids submitted in response to Specification No. 18-954-00/RFQ 64443; and be it

FURTHER RESOLVED: That the contract shall be approved for form and legality by the City Attorney and copies shall be on file in the City Clerk's Office.
