Pursuant to Section 401 of the Charter, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled claim for the sum of Four Hundred and Fifty Thousand Dollars and Zero Cents (\$450,000.00), payable to Joseph Torres.

This action arises out of a lawsuit filed by Captain Torres against the City and former Oakland Fire Chief Teresa Deloach Reed alleging that she discriminated and retaliated against him when she did not promote him to battalion chief.

The Council authorized settlement of this case in Closed Session on Tuesday, April 17, 2018 (moved by Campbell Washington and seconded by Gibson McElhaney - 4 Ayes, 1 No - Kalb, 1 Abstention – Kaplan, and 2 Absent - Brooks and President Reid).

RESOLUTION AUTHORIZING AND DIRECTING THE CITY ATTORNEY TO COMPROMISE AND SETTLE THE CASE OF JOSEPH TORRES V. CITY OF OAKLAND, ET AL., UNITED STATES DISTRICT COURT CASE NO. 15-5075-JSC, CITY ATTORNEY'S FILE NO. X04219, IN THE AMOUNT OF FOUR HUNDRED AND FIFTY THOUSAND DOLLARS AND ZERO CENTS (\$450,000.00) (OAKLAND FIRE DEPARTMENT – DISCRIMINATION/RETALIATION, FAILURE TO PROMOTE)
WHEREAS, Plaintiff Joseph Torres alleges that Oakland Fire Chief Teresa Deloach Reed discriminated and retaliated against him when she failed to promote him from the 2012-2014 battalion chief eligibility list; and
WHEREAS , On November 9, 2015, Joseph Torres filed a complaint in federal court for damages against the City alleging discrimination and retaliation and a violation of his civil rights; and
WHEREAS, without admitting fault or wrongdoing, the City has determined to compromise and settle Plaintiff Joseph Torres's claims against it for the sum of Four Hundred and Fifty Thousand Dollars and Zero Cents (\$450,000.00); now, therefore, be in
RESOLVED: That the City Attorney is authorized and directed to compromise and settle the case of Joseph Torres v. City of Oakland, et al., United States District Court Case No. 15-5075-JSC, City Attorney's File No. X04219, for a sum not to exceed Four Hundred and Fifty Thousand Dollars and Zero Cents (\$450,000.00) payable by the City of Oakland; and be it
FURTHER RESOLVED: That the City Attorney is further authorized and directed to take whatever steps necessary to effect said settlement; and be it
FURTHER RESOLVED: That the sum of Four Hundred and Fifty Thousand Dollars and Zero Cents (\$450,000.00) be made payable to Joseph Torres.
