RECOMMENDATION

Staff Recommends That The City Council Conduct A Public Hearing And Upon Conclusion Adopt A Resolution 1)Accepting And Confirming Reports Of The City Administrator On The Costs Incurred By The City Of Oakland For Delinquent Business Taxes And 2) Confirming The Recordation Of Liens With Administrative And Assessment Charges As Necessary Pursuant To Chapter 5.04 Of The Oakland Municipal Code, And 3) Directing The Notice Of Lien And Assessment Charges Be Turned Over To The County Tax Collector For Collection.

EXECUTIVE SUMMARY

Adoption of the proposed resolution will authorize the placement of liens on real property for unpaid Business Taxes ("BT") and authorize the subsequent assessment, pursuant to Chapter 5.04 of the Oakland Municipal Code (O.M.C.), should the fees and charges remain unpaid prior to the transfer/recording of said special assessment levies to the Tax Collector and Auditor Controller for inclusion on the next property tax roll. The liens will be recorded against 417 delinquent parcels in an amount of \$3,088,118.72, as well as \$52,125 for administrative fees, for a total property tax roll of \$3,140,243.72. Failure to place liens to recover the delinquent taxes will result in a loss of \$3,140,243.72 in revenues to the General Purpose Fund.

BACKGROUND / LEGISLATIVE HISTORY

Pursuant to Chapter 5.04 of the Oakland Municipal Code, staff cross-referenced Alameda County Assessor data with the business tax system data to identify potential noncompliant/delinquent business operators owning various types of properties. During a review and assessment process, 672 property owners were notified to address delinquent business taxes determined to be owed to the City. An administrative hearing for delinquent business taxes was held on May 8, 2018 to hear protests and to resolve any inconsistencies or inequities raised by the property owners regarding the non-payment of business taxes. Property owners were given the opportunity to appeal their cases in this administrative process. The public hearing before City Council is scheduled for June 19, 2018. A resolution is prepared confirming the placement of liens on 417 properties and authorizing the subsequent assessment for all fees and charges.

ANALYSIS AND POLICY ALTERNATIVES

Administrative hearings for delinquent business taxes were held on May 8, 2018 to hear protests and resolve inconsistencies or inequities raised by property owners regarding the non-payment of business taxes.

A total of 15 taxpayers appeared at the Fourth Quarter Lien (4QL) Administrative Hearing on May 8, 2018 yielding the following results:

- 11 accounts were PAID in full.
- One account was CLOSED.
- Three accounts remain unresolved as the taxpayers appeared without proper documentation and were asked to return on or before June 19, 2018.

Ultimately, of the originally identified 672 properties identified for delinquent business taxes. 255 properties were deleted from the list through the administrative hearing process, payments, and/or account closures.

The remaining 417 non-responders were notified of the City's intent to record a lien against their property; these remaining parcels are subject to lien. A resolution has been prepared confirming the placement of liens on 417 properties and authorizing the subsequent assessment for all fees and charges. A breakdown by property type of the parcels are as follows (*Table 1*):

Approximately 67 of the 417 properties have been identified as possible owner-occupied, the property parcel and mailing address being the same. Of the properties identified as Single Family Residential, 29 have been identified as owner-occupied, the property parcel and mailing address being the same.

On June 20, 2017, staff submitted an agenda report recommending that the City Council conduct a public hearing and upon conclusion adopt a resolution accepting and confirming reports of the City Administrator on the costs incurred by the City of Oakland for delinquent business taxes and confirming the recordation of liens with administrative and assessment charges for 179 properties as necessary pursuant to Chapter 5.04 Oakland Municipal Code, and directing the notice of lien and assessment charges be turned over to the County Tax Collector for collection. No action was taken and the item was returned to staff pending feedback from City Council. Since that time, eight properties have been sold and are no longer eligible for the recovery of delinquent tax revenue through the lien process with a projected revenue loss of \$13,295.

Following the administrative hearings, the Finance Director filed with the City Administrator a written notice of those property owners on whom the City will file liens for unpaid taxes, penalties, interest, and other charges. If these amounts remain unpaid or unresolved after a public hearing by the City Council, the City Council shall authorize by resolution the recordation of liens on the subject properties for costs incurred for delinquent business taxes, and additional administrative charges and assessments. The delinquent charges and assessments shall constitute a special assessment against said property, and shall be collected at the time established by the County Assessor for inclusion in the next property tax assessment.

FISCAL IMPACT

A list of delinquent business taxes and administrative fees for the accounts not resolved at the administrative hearings are shown in *Attachment 1*. Failure to place these liens will result in the loss of \$3,088,118.72 in General Purpose Fund revenues and \$52,125 in administrative fees, for a total of \$3,140,243.72 over this period.

PUBLIC OUTREACH / INTEREST

Property owners were notified and an administrative hearing for delinquent business taxes were held on May 8, 2018; to hear protests and resolve any inconsistencies or inequities raised by property owners regarding the non-payment of business taxes, in which each property owner subject to a property lien were sent a lien notice on April 27, 2018.

COORDINATION

In coordination with the Office of the City Attorney and the Budget Bureau, the agenda report, resolutions, and supporting items attached to this report, as well as the accompanying resolution, have been reviewed and/or approved for form, legality and fiscal implications.

SUSTAINABLE OPPORTUNITIES

Economic: Collections of delinquent business taxes have major economic implications for the City's sustainability. The revenue source is relied upon to fund essential City services.

Environmental: There are no environmental opportunities resulting from the recordation of liens.

Social Equity: Collections of delinquent business taxes have significant social equity implications for the City's sustainability. The revenue source is relied upon to fund essential City services to all citizens and taxpayers.
