ORDINANCE AMENDING CHAPTER 2.29 OF THE OAKLAND MUNICIPAL CODE ENTITLED "CITY AGENCIES, DEPARTMENTS AND OFFICES" TO REPEAL AND RE-ENACT SECTION 2.29.090 TO RENAME THE OAKLAND PARKS & RECREATION DEPARTMENT TO THE "OAKLAND PARKS, RECREATION & YOUTH DEVELOPMENT DEPARTMENT"

**WHEREAS**, Section 600 of the Charter of the City of Oakland provides that the City Council shall by ordinance provide the form of the organization through which the functions of the City under the jurisdiction of the City Administrator are to be administered; and

**WHEREAS,** Chapter 2.29 of the Oakland Municipal Code is revised from time to time when the structure or description of the City organization changes; now, therefore

## THE COUNCIL OF THE CITY OF OAKLAND DOES ORDAIN AS FOLLOWS:

**Section 1**. The City Council finds and determines the foregoing recitals to be true and correct and hereby adopts and incorporates them into this Ordinance.

**Section 2.** Oakland Municipal Code Chapter 2.29, which establishes the City of Oakland organizational structure, is hereby amended to repeal Section 2.29.090, which establishes the Oakland Parks & Recreation Department, and re-enact Section 2.29.090 as set forth below, with additions indicated by <u>underscoring</u> and deletions are indicated by strike through type; portions of the Chapter not cited or not shown in underscoring or strike-through type are re-enacted without change.

2.29.090 - Oakland Parks, & Recreation & Youth Development Department.

There is established in the City government an Oakland Parks, &-Recreation & Youth <u>Development</u> Department, which shall be under the supervision and administrative control of the City Administrator. The powers, functions and duties of said Department shall be those assigned, authorized and directed by the City Administrator. The management and operation of the Oakland Parks, &-Recreation & Youth Development Department shall be the responsibility of the Director of Parks & Recreation, subject to the direction of the City Administrator. **Section 3.** If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of the remaining portions of this ordinance. The City Council declares that it would have adopted this Ordinance and each section, subsection, sentence, clause and phrase thereof, irrespective of the fact that any one or more section, subsection, sentence, clause, or phrase be declared invalid.

**Section 4.** This ordinance shall become effective immediately on final adoption if it receives six or more affirmative votes; otherwise it shall become effective upon the seventh day after final adoption. The organizational structure established by this Ordinance will become effective on June 1, 2018.
