ORDINANCE AMENDING OAKLAND MUNICIPAL CODE TITLE II TO ADD CHAPTER 2.05, WHICH WILL ESTABLISH PROCEDURES FOR THE ACQUISITION (ALSO REFERENCED AS "ACCESSION") AND DISPOSITION (ALSO REFERENCED AS "DEACCESSION") OF ARTIFACTS AND OTHER ITEMS FOR/FROM THE LISTED HOLDINGS OF THE OAKLAND MUSEUM OF CALIFORNIA (OMCA)

This ordinance will amend the Oakland Municipal Code to add new Chapter 2.05, which will establish procedures for the acquisition, disposition (sale or disposal) of City of Oakland museum real property that is owned by the City of Oakland, such as art works, historical artifacts, photographs and natural science specimens, including all listed holdings of the Oakland Museum of California.
