AN ORDINANCE ADDING A NEW ARTICLE TO O.M.C. CHAPTER 8.22 TO (1) REGULATE TEN-ANT MOVE OUT AGREEMENTS AND NEGOTIA-TIONS, (2) CREATE DISCLOSURE AND REPORT-ING REQUIREMENTS FOR SUCH AGREEMENTS AND NEGOTIATIONS, AND (3) PROVIDE REM-EDIES FOR VIOLATIONS
