FURTHER RESOLVED, that pursuant to City Charter section 601, the City Council hereby confirms the Mayor's appointment of Nischit Hedge to serve a threeyear term on the City Planning Commission, beginning May 5, 2018 and ending May 4, 2021, filling the seat previously held by Adhi Nagraj; and be it FURTHER RESOLVED, that pursuant to City Charter section 601, the City Council hereby confirms the Mayor's appointment of Sahar Shirazi to serve a three-year term on the City Planning Commission, beginning May 5, 2018 and ending May 4, 2021, filling the seat previously held by Emily Weinstein.
