### RECOMMENDATION

Staff Recommends That The City Council Adopt A Resolution Authorizing The City Administrator To Award A Construction Contract To The Lowest Responsive And Responsible Bidder, In Accordance With Project Plans and Specifications, For The Pedestrian Lighting And Sidewalk Improvements On International Boulevard From 42<sup>nd</sup> Avenue To 107<sup>th</sup> Avenue Project (Project No. 1000844) In An Amount Not-To-Exceed Four Million Dollars (\$4,000,000.00).

#### EXECUTIVE SUMMARY

Approval of this resolution will allow the City Administrator to award a construction contract for the Pedestrian Lighting and Sidewalk Improvements on International Boulevard from 42<sup>nd</sup> Avenue to 107<sup>th</sup> Avenue Project (Project No. 1000844) in an amount not-to-exceed four million dollars (\$4,000,000.00) to the lowest responsive and responsible bidder. The work is located in Council Districts 2, 5, 6 and 7 as shown in *Attachment A*.

The project includes installation of pedestrian light poles and fixtures, pull boxes, electrical conduit, electrical conductor, replacement of damaged sidewalks and driveways, and other minor incidental items including tree root pruning and curb and gutter replacement.

#### BACKGROUND/LEGISLATIVE HISTORY

The Pedestrian Lighting and Sidewalk Improvements On International Boulevard from 42<sup>nd</sup> Avenue to 107<sup>th</sup> Avenue Project will provide a safer walking experience for pedestrians along International Boulevard in conjunction with AC Transit's East Bay Bus Rapid Transit (BRT) project, as it will draw many pedestrians to the corridor.

The AC Transit's BRT project will be providing a new service along the International Blvd, connecting downtown Oakland to the San Leandro BART Station with bus-only lanes, improved

Item: \_\_\_\_\_ Public Works Committee July 17, 2018 accessible stations, and utilizing transit signal technology thus increasing bus arrival and travel time. While the BRT project included improvements for pedestrians at bus stops, it does not provide pedestrian lighting and sidewalk improvements in between the bus stops.

The City of Oakland applied for and was awarded a \$2,481,000.00 federal Active Transportation Program (ATP) grant. The grant was approved by City Council Resolution No. 85106 C.M.S. on July 15, 2014 as shown in *Attachment B*.

### **ANALYSIS / POLICY ALTERNATIVES**

The Pedestrian Lighting And Sidewalk Improvements On International Boulevard From 2<sup>nd</sup> Avenue To 107<sup>th</sup> Avenue Project (1000844) was advertised for bids on March 9, 2018. Direct outreach was performed to various contractors, but only two bids were received on April 12, 2018, and they were at \$7,388,993.00 and \$9,558,885.50. The Engineer's Estimate was \$3,849,840.00. Both bidders did not comply with the federal Disadvantaged Business Enterprise (DBE) requirements. Therefore, both bids were deemed unresponsive.

The grant deadline to award the construction contract was May 31, 2018. The City is coordinating with the California Transportation Commission (CTC), to extend the award deadline if the City conditionally awards the construction contract by July 31, 2018.

If the ATP award deadline cannot be extended, staff proposes an alternate source of funding to complete the project funding and keep it on schedule. This funding source is from \$4,792,000 in One Bay Area Grant (OBAG) funds granted to the City for design and construction of the Lakeside Family Streets project, and accepted and appropriated by Council on June 20, 2017 (Resolution No. 86791 C.M.S.), as shown in **Attachment C**. The engineering design phase of the Lakeside Family Streets project has not yet begun, and in this scenario engineering design will remain fully funded and alternate sources of funding will be sought to complete construction. The Metropolitan Transportation Commission (MTC) has agreed to propose reprogramming the funds for this purpose, if needed.

The project was re-advertised on June 15, 2018 with a reduced scope which included work from 65<sup>th</sup> Avenue to 107<sup>th</sup> Avenue with an Engineer's Estimate of \$2,023,053.00. A bid alternate is included to allow the project to extend to 42<sup>nd</sup> Avenue if available funds allow. The Engineer's Estimate for the bid alternate work is \$1,085,455.80.

The bid opening is on July 10, 2018. Bids will be analyzed by Contracts and Compliance Division for DBE participation and Equal Benefits Ordinance (EBO) compliance. To meet the funding

Item: \_\_\_\_\_ Public Works Committee July 17, 2018 deadline, staff requests that the City Council approve the resolution authorizing the City Administrator to award a contract to the lowest responsive and responsible bidder in an amount not-to-exceed four million dollars (\$4,000,000.00).

The current bidding climate has been drastically changing, with bid prices being received at 30% and above the engineering estimates. Therefore, to ensure contract award, staff has recommended placing the "Not-To-Exceed" amount at a minimum of 30% above the estimate. This would place the City's "Not-To-Exceed" limit at four million dollars (\$4,000,000.00). Construction work is anticipated to begin this fall 2018 and should be completed by Summer 2019 contingent on weather conditions. The contract specifies \$2,330.00 in liquidated damages per calendar day if the contractor exceeds the contract completion time of 120 working days.

### FISCAL IMPACT

Approval of this resolution will allow the City Administrator to execute a construction contract with the lowest responsive and responsible bidder in an amount not-to-exceed \$4,000,000.00.

### SUSTAINABLE OPPORTUNITIES

*Economic*: This project will improve transportation conditions and make the International Boulevard corridor safer, well lit, and more attractive. 

(A) APPLY FOR, ACCEPT AND APPROPRIATE UP TO SEVENTEEN MILLION THREE HUNDRED ELEVEN THOUSAND ONE HUNDRED SIXTY DOLLARS (\$17,311,160.00) IN ACTIVE TRANSPORTATION PROGRAM FUNDS ASSIGNED TO THE METROPOLITAN TRANSPORTATION COMMISSION;

**(B) COMMIT MATCHING FUNDS OF UP TO SIX HUNDRED FORTY SEVEN** THOUSAND FOUR HUNDRED SIXTY DOLLARS (\$647,460.00) FROM MEASURE B (FUND 2211) GRANT MATCHING FUNDS

WHEREAS, the City of Oakland ("City") is submitting an application to the Metropolitan Transportation Commission ("MTC") for Seventeen Million Three Hundred Eleven Thousand One Hundred Sixty Dollars (\$17,311,160.00) in funding assigned to MTC for programming discretion, which includes federal funding administered by the Federal Highway Administration ("FHWA") and federal or state funding administered by the California Transportation Commission ("CTC") such as Surface Transportation Program ("STP") funding, Congestion Mitigation and Air Quality Improvement ("CMAQ") funding, Transportation Alternatives ("TA")/Active Transportation Program ("ATP") funding, and Regional Transportation Improvement Program ("RTIP") funding, herein collectively referred to as Regional

Discretionary Funding, for the following projects:

International Boulevard Corridor Pedestrian Projects

- International Boulevard Pedestrian Lighting and Sidewalk Repair Project (\$2,481,000.00)
- International Boulevard Pedestrian Refuges Project (\$602,120.00)

(herein referred to as Projects) for the Active Transportation Program ("ATP"); and

WHEREAS, the Moving Ahead for Progress in the 21<sup>st</sup> Century Act (Public Law 112-141, July 6, 2012) and any extensions or successor legislation for continued funding (collectively, MAP 21) authorize various federal funding programs including, but not limited to the Surface Transportation Program (STP) (23 U.S.C. § 133), the Congestion Mitigation and Air Quality Improvement Program (CMAQ) (23 U.S.C. § 149) and the Transportation Alternatives Program (TA) (23 U.S.C. § 213); and

WHEREAS, State statutes, including California Streets and Highways Code §182.6, §182.7, and §2381(a)(1), and California Government Code §14527, provide various funding programs for the programming discretion of the Metropolitan Planning Organization (MPO) and the Regional Transportation Planning Agency (RTPA); and

WHEREAS, pursuant to MAP-21, and any regulations promulgated thereunder, eligible project sponsors wishing to receive federal or state funds for a regionally-significant project shall submit an application first with the appropriate MPO, or RTPA, as applicable, for review and inclusion in the federal Transportation Improvement Program (TIP); and

WHEREAS, MTC is the MPO and RTPA for the nine counties of the San Francisco Bay region; and

WHEREAS, MTC has adopted a Regional Project Funding Delivery Policy (MTC Resolution No. 3606, revised) that sets out procedures governing the application and use of Regional Discretionary Funding; and

WHEREAS, the City is an eligible sponsor for Regional Discretionary Funding; and

**FURTHER RESOLVED** that, in the case of an RTIP project, Projects is included in a local congestion management plan, or is consistent with the capital improvement program adopted pursuant to MTC's funding agreement with the countywide transportation agency; and be it

**FURTHER RESOLVED** that the City is an eligible sponsor of Regional Discretionary Funding funded projects; and be it

**FURTHER RESOLVED** that the City is authorized to submit an application for Regional Discretionary Funding for the Projects; and be it

FURTHER RESOLVED that there is no legal impediment to the City making applications for the funds; and be it

FURTHER RESOLVED that there is no pending or threatened litigation that might in any way adversely affect the proposed Projects, or the ability of the City to deliver such Projects; and be it

**FURTHER RESOLVED** that the City authorizes its City Administrator, or designee to execute and file an application with MTC for Regional Discretionary Funding for the Projects as referenced in this resolution; and be it

**FURTHER RESOLVED** that the MTC is requested to support the application for the Projects described in the resolution, and if approved, to include the Projects in MTC's federal TIP upon submittal by the project sponsor for TIP programming; and be it

**FURTHER RESOLVED** that the City Council hereby appropriates funds in an amount not to exceed \$17,311,160.00 that are received for these Projects under the ATP Program into the MTC Program Fund (Fund 2163) under project numbers to be established; and be it

**FURTHER RESOLVED** that the City Council hereby consents the use of up to \$647,460.00 in matching funds for the Laurel Access to Mills Maxwell Park and Seminary Active Transportation Connections Project from Fund 2211 (Local Street and Roads, Grants Matching Fund); and be it



RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR OR DESIGNEE TO APPLY FOR, ACCEPT AND APPROPRIATE NINE MILLION SIX HUNDRED EIGHTY SEVEN THOUSAND DOLLARS (\$9,687,000) IN ONE BAY AREA GRANT FUNDS FROM THE METROPOLITAN TRANSPORTATION COMMISSION FOR THE OAKLAND LOCAL STREETS AND ROADS (LSR) PAVING PROGRAM PROJECT AND THE LAKESIDE FAMILY STREETS PROJECT; COMMIT MATCHING FUNDS OF UP TO ONE MILLION TWO HUNDRED FIFTY SEVEN THOUSAND DOLLARS (\$1,257,000); AND ASSURE COMPLETION OF THE PROJECTS

WHEREAS, the City of Oakland (City) is submitting an application to the Metropolitan Transportation Commission (MTC) for Nine Million Six Hundred Eighty Seven Thousand Dollars (\$9,687,000) in funding assigned to MTC for programming discretion, which includes federal funding administered by the Federal Highway Administration (FHWA) and federal or state funding administered by the California Transportation Commission (CTC) such as Surface Transportation Block Grant Program (STP) funding, Congestion Mitigation and Air Quality Improvement Program (CMAQ) funding, Transportation Alternatives (TA) set-aside/Active Transportation Program (ATP) funding, and Regional Transportation Improvement Program (RTIP) funding (herein collectively referred to as Regional Discretionary Funding) for the Oakland LSR Paving Program Project and the Lakeside Family Streets Project (Projects) for the One Bay Area Grant Program (Program); and

WHEREAS, the United States Congress from time to time enacts and amends legislation to provide funding for various transportation needs and programs, (collectively, the Federal Transportation Act) including, but not limited to the Surface Transportation Block Grant Program (STP) (23 U.S.C. § 133), the Congestion Mitigation and Air Quality Improvement Program (CMAQ) (23 U.S.C. § 149) and the Transportation Alternatives (TA) set-aside (23 U.S.C. § 133); and

WHEREAS, state statutes, including California Streets and Highways Code §182.6, §182.7, and §2381(a)(1), and California Government Code §14527, provide various funding programs for the programming discretion of the Metropolitan Planning Organization (MPO) and the Regional Transportation Planning Agency (RTPA); and

WHEREAS, pursuant to the Federal Transportation Act, and any regulations promulgated thereunder, eligible project sponsors wishing to receive federal or state funds for a regionally-significant project shall submit an application first with the appropriate MPO, or RTPA, as applicable, for review and inclusion in the federal Transportation Improvement Program (TIP); and

WHEREAS, MTC is the MPO and RTPA for the nine counties of the San Francisco Bay region; and

WHEREAS, MTC has adopted a Regional Project Funding Delivery Policy (MTC Resolution No. 3606, revised) that sets out procedures governing the application and use of Regional Discretionary Funding; and

WHEREAS, the City is an eligible sponsor for Regional Discretionary Funding; and

**WHEREAS**, as part of the application Regional Discretionary Funding, MTC requires a resolution adopted by the responsible implementing agency stating the following:

- the commitment of any required matching funds; and
- that the sponsor understands that the Regional Discretionary Funding is fixed at the programmed amount, and therefore any cost increase cannot be expected to be funded with additional Regional Discretionary Funding; and
- that the Projects will comply with the procedures, delivery milestones and funding deadlines specified in the Regional Project Funding Delivery Policy (MTC Resolution No. 3606, revised); and
- the assurance of the sponsor to complete the Projects as described in the application, subject to environmental clearance, and if approved, as included in MTC's federal Transportation Improvement Program (TIP); and
- that the Projects will have adequate staffing resources to deliver and complete the Projects within the schedule submitted with the project application; and
- that the Projects will comply with all project-specific requirements as set forth in the Program; and
- that the City has assigned, and will maintain a single point of contact for all FHWA- and CTC-funded transportation projects to coordinate within the agency and with the respective Congestion Management Agency (CMA), MTC, Caltrans, FHWA, and CTC on all communications, inquires or issues that may arise during the federal programming and delivery process for all FHWA- and CTC-funded transportation and transit projects implemented by the City; and

WHEREAS, that the City is authorized to submit an application for Regional Discretionary Funding for the Project; and

WHEREAS, there is no legal impediment to the City making applications for the funds; and

WHEREAS, there is no pending or threatened litigation that might in any way adversely affect the proposed Projects, or the ability of the City to deliver such Projects; and

WHEREAS, the City authorizes its City Administrator or designee to execute and file an application with MTC for Regional Discretionary Funding for the Projects as referenced in this resolution; and

WHEREAS, MTC requires that a copy of this resolution be transmitted to the MTC in conjunction with the filing of the application; now, therefore be it

**RESOLVED** that the City is authorized to execute and file an application for funding for the Projects for Regional Discretionary Funding under the Federal Transportation Act or continued funding; and be it

FURTHER RESOLVED that the City will provide any required matching funds; and be it

**FURTHER RESOLVED** that City understands that the Regional Discretionary Funding for the project is fixed at the MTC approved programmed amount, and that any cost increases must be funded by the City from other funds, and that City does not expect any cost increases to be funded with additional Regional Discretionary Funding; and be it

**FURTHER RESOLVED** that City understands the funding deadlines associated with these funds and will comply with the provisions and requirements of the Regional Project Funding Delivery Policy (MTC Resolution No. 3606, revised) and City has, and will retain the expertise, knowledge and resources necessary to deliver federally-funded transportation and transit projects, and has assigned, and will maintain a single point of contact for all FHWA- and CTC-funded transportation projects to coordinate within the agency and with the respective Congestion Management Agency (CMA), MTC, Caltrans, FHWA, and CTC on all communications, inquires or issues that may arise during the federal programming and delivery process for all FHWA- and CTC-funded transportation and transit projects implemented by the City; and be it
