

AN ORDINANCE AMENDING ORDINANCE NO. 13448 C.M.S. (THE FISCAL YEAR 2017-18 MASTER FEE SCHEDULE, OR "MFS"), TO ESTABLISH, MODIFY AND DELETE FEES AND PENALTIES ASSESSED BY OFFICES, DEPARTMENTS, BUREAUS, AND AGENCIES OF THE CITY OF OAKLAND, REFERENCED HEREIN.

This Ordinance authorizes an amendment to Ordinance Number 13448 C.M.S. (The FY 2017-18 Master Fee Schedule, or "MFS"), to establish, modify and delete fees and penalties assessed by offices, departments, bureaus, and agencies of the City of Oakland. The first public reading of this ordinance is scheduled at a public hearing on 5/15/18 and second on 5/29/18. The location is at City Council Chambers located on the Third Floor of City Hall, One Frank H. Ogawa Plaza, Oakland, California, at 5:30pm. Upon final adoption of the Ordinance, fees will be effective on July 1, 2018 and will remain in effect until further notice.
