RECOMMENDATION

Staff Recommends That The City Council Receive An Informational Report Responding To Resolution No. 87129-C.M.S. Requesting Information Concerning A Number Of Different Homeless Services And Programs.

REASON FOR SUPPLEMENTAL REPORT

Since the writing of the agenda report dated August 20, 2018, the City of Oakland has submitted a grant application to the State of California for Homeless Emergency Aid Program (HEAP) funds in the amount of \$8,671,116.82. (Attachment A). The City expects to receive these funds by early November; staff will return to City Council to request authority to accept and appropriate the funds. The funds will bolster the City's ability to provide immediate emergency assistance to people experiencing unsheltered homelessness in Oakland. Services include increased health and hygiene interventions in encampments (portable toilets, wash stations, showers, garbage pickup), an increase in year-round and seasonal shelter beds, up to 5 additional Community Cabins sites (Tuff Shed intervention), up to 10 safe parking sites, flex funds for unsheltered families (motel vouchers and rapid rehousing subsidies), and funds dedicated to addressing unsheltered youth (increased shelter, increased outreach). All services are designed to be low barrier, follow a housing first model, and to have a quick and direct impact on people living on the streets.

Alameda County will also submit its HEAP application this fall. The City's application was submitted after conversations with the County about the best ways to align the City and County HEAP applications to amplify the impact of the funds.
