YUI HAY LEE Principal

Yui Hay Lee is President and founder of Y. H. Lee Associates (YHLA), an architectural and planning firm in Oakland, California. Throughout the three and half decades of YHLA, Mr. Lee has been committed to excellence in design and to providing the highest caliber of architectural services with his enthusiastic personal touch. This commitment has earned YHLA a prestigious roster of satisfied and repeat clients.

Born in China and raised in Hong Kong, Mr. Lee won an international scholarship to attend Miami University in Oxford, Ohio. He graduated in 1965 with a Bachelor of Architecture degree, having been awarded numerous honors for academic and design excellence. These included the Alpha Rho Chi Architectural Medal for the best graduating architectural student, and a scholarship to the prestigious Ecole Des Beaux Arts in Fontainebleau, France, where he earned a Diploma in Architecture with honors. In 1967, he received his Master of Architecture in Urban Design from the Graduate School of Design at Harvard University.

In 1967, Mr. Lee was recruited by RTKL Associates, Inc., a multi-disciplinary architectural firm in Baltimore, Maryland. He became an Associate in 1970 and an Associate Principal in 1979. During his 13-year tenure with RTKL, Mr. Lee worked on a number of large-scale architectural and urban design projects throughout the country. In 1980, he moved to San Francisco as an Associate with the firm of Bull Field Volkmann and Stockwell. Mr. Lee launched his own practice, Y. H. Lee Associates (YHLA), in 1981.

YHLA under the leadership of Mr. Lee practices in California, the State of Florida, the Republic of China in Taiwan, and the People's Republic of China. Because of its capabilities, experience and willingness to aggressively pursue optimal design solutions, the firm has become recognized for its successful delivery of large-scale development projects, ranging from resort complexes and multi-phased high-rise apartments to regional shopping centers and professional sports facilities. YHLA produced the winning design in the Oakland City Hall Plaza Competition, with construction completed in October 1998. Other significant local projects included the renovation and addition of the Terminal 2 in Oakland International Airport which also included the Southwest Terminal and the renovated Oracle Arena in Oakland as the project's Associate Architect. Recently, the firm completed the office headquarter of the Aviation Division of the Port of Oakland in Terminal One;

Long active in local public affairs, Mr. Lee is currently a Commissioner of the Oakland-Alameda County Coliseum Authority, and he sits on the Advisory Board of the former OneCalifornia Bank. Previously he was member of the Oakland Landmarks Preservation Advisory Board and a member of the City Planning Commission for the City of Oakland from 1991 to 1994, chairing the Commission in 1993-1994. He was a member of the Coordinating Committee for the Strategic Plan for Oakland. He has served as president of the East Bay Chapter of the Organization of Chinese Americans; as vice president of both the Oakland Asian Cultural Center and the Oakland Consolidated Chinese Association; and on the Board of Directors of Coalition of Chinatown Development, the Chinatown Project Area Committee, the Metropolitan Oakland Chamber of Commerce, the College Preparatory School in Oakland and the Summit Hospitals Foundation of Oakland.

Mr. Lee and his wife Suzie reside in Oakland. They have two children, Lonlone, 42, and Yenyen Lee Chow, 39.
