WHEREAS, the same salary increases of the Memorandum of Understanding shall apply to the salary range of the unrepresented Unit UN1 classification, Chief of Police; and

WHEREAS, the terms and conditions contained in said Memorandum of Understanding are in the best interests of the City; now, therefore, be it

RESOLVED: That said agreement be, and is, hereby approved; and be it

FURTHER RESOLVED: That the provisions of said Memorandum of Understanding are effective upon ratification and/or as set forth in the Report from the City Administrator dated November 20, 2018.
