RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR OR DESIGNEE TO ENTER INTO A TOTAL OF SEVEN (7) PROFESSIONAL SERVICES AGREEMENTS FOR ON-CALL GEOTECHNICAL ENGINEERING SERVICES, TIER II, IN IN THE AMOUNT OF SEVEN HUNDRED FIFTY THOUSAND DOLLARS (\$750,000) EACH WITH: 1) AGS INC., 2) ARUP, 3) CAL ENGINEERING AND GEOLOGY, 4) FUGRO, 5) LANGAN ENGINEERING AND ENVIRONMENTAL SERVICES, INC., 6) NINYO AND MOORE, AND 7) TERRAPHASE ENGINEERING INC.

WHEREAS, professional on-call geotechnical engineering services are needed to provide oncall geotechnical engineering services on various projects. The services are needed to design and review public roadway damage and slope stability restoration projects; and

WHEREAS, on-call geotechnical engineering services allow Oakland Department of Transportation (OakDOT) to respond and provide the necessary services in an efficient and timely manner; and

WHEREAS, on-call geotechnical engineering services allow OakDOT to promote greater efficiency and safety within the transportation network; and

WHEREAS, OakDOT anticipates that the possibly of severe winter storms may cause landslides and collapse roadways, will utilize the on-call geotechnical engineering services contracts; and

WHEREAS, mid-year projects will arise throughout the three-year period will likely require oncall geotechnical engineering services; and

WHEREAS, on-call geotechnical engineering services will be funded through the various individual projects and funds will be identified prior to the performance of the on-call services; and

WHEREAS, the City issued a Request for Qualifications (RFQ) in accordance with Oakland Municipal Code, OMC Chapter 2.04.051; and

WHEREAS, through the City's Request for Qualifications process, seven Tier II firms have met the City's 50% Local/Small Local Business Enterprises (LBE/SLBE) Program requirements and have been determined to be in compliance with the Equal Benefits Ordinance (EBO); and

WHEREAS, the City Council finds that the services provided pursuant to the contracts authorized hereunder are of a professional, scientific or technical nature and are temporary in nature; and

WHEREAS, the City Council finds that the contracts shall not result in the loss of employment or salary by any person having permanent status in the competitive service; now, therefore be it

RESOLVED: That the City Council authorize the City Administrator to execute a Professional Services Agreement Contract with On-Call Geotechnical Engineering Services with six Tier II firms: 1) AGS Inc., 2) ARUP, 3) Cal Engineering and Geology, 4) FUGRO., 5) Langan Engineering and Environmental Services, Inc., 6) Ninyo and Moore and 7) Terraphase Engineering Inc.

FURTHER RESOLVED: That the total amount of the Contract for each of the six Tier II firms shall be for a not-to-exceed amount of \$750,000; and be it

FURTHER RESOLVED: That the terms of each Contract shall be for three (3) years; and be it

FURTHER RESOLVED: That the City Administrator, or designee, is hereby authorized to approve any subsequent amendments to or extensions of said Contracts with the exception of those related to an increase in total compensation or the allocation of funds, provided that such amendments or extensions shall be approved for form and legality by the City Attorney and a copy shall be kept on file with the City Clerk; and be it

FURTHER RESOLVED: That the Contracts shall be approved for form and legality by the City Attorney, and a copy shall be kept on file with the City Clerk.
