### Barbara Leslie, MPA Curriculum Vitae

Barbara Leslie has a 25-year career in public service, workforce development, and public policy spanning the nonprofit, private and public sectors. In 1993 as a graduate student in public administration Ms. Leslie worked for Oakland Mayor Elihu Harris; successfully developing a city-wide employment program. She then held key public policy positions with the Oakland Association of Realtors, the Oakland Metropolitan Chamber of Commerce and the Port of Oakland. While at the Port, she handled government and community relations efforts on the municipal, state and federal levels. In 1999 Ms. Leslie was recruited to be Assistant to the City Manager of Oakland under City Manager Robert Bobb and Mayor Jerry Brown, where she was responsible for the Budget Office, Fire Department, Public Works Agency, and Human Resources. Ms. Leslie was a key architect of the City of Oakland's Capital Improvement Program as well as the 2001-2003 Fiscal Year Budget. Subsequent to her work in government, Ms. Leslie was Director of External Affairs for AT&T in Alameda and Contra Costa Counties. In 2014 she became the first woman President & CEO in the 110-year history of the Oakland Metropolitan Chamber of Commerce, where she is able to put her decades of experience to use every day in service of the town she is proud to call home.

Ms. Leslie has served on numerous non-profit and governmental boards including Visit Oakland, the Oakland African American Chamber of Commerce, and the Youth Employment Partnership.
