WHEREAS, the Tentative Agreement and Memorandum of Understanding to be entered into between the City of Oakland and the Oakland Police Management Association ("OPMA") has been presented to the City Council for determination pursuant to Section 3505.1 of the Government Code of the State of California; and

WHEREAS, the key provisions of the Memorandum of Understanding are described in the Report from the City Administrator dated November 20, 2018; and

WHEREAS, the same salary increases and terms and conditions of the Memorandum of Understanding shall apply to the unrepresented Unit UN1 classification, Assistant Chief of Police; and

WHEREAS, the same salary increases of the Memorandum of Understanding shall apply to the salary range of the unrepresented Unit UN1 classification, Chief of Police; and

WHEREAS, the terms and conditions contained in said Memorandum of Understanding are in the best interests of the City; now, therefore, be it
