OF THE OAKLAND MUNICIPAL CODE TO ADD
56th ST AND 58™ ST BETWEEN SHATTUCK AVE
AND TELEGRAPH AVE TO THE LIST OF CITY
STREETS WHERE COMMERCIAL VEHICLES EXCEEDING FOUR AND ONE-HALF TONS ARE PROHIBITED
