President Kaplan and Members of the City Council:

Pursuant to Section 401 of the Charter, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled claim for the sum of Fifty Three Thousand Thirty Dollars and Forty-Two Cents (\$53,030.42), payable to Mario Moore.

On April 4, 2017, Mr. Moore tripped on uneven sidewalk on the north side of the 800 block of West Grand Avenue (between Curtis Street and West Street). He sustained a left traverse patella fracture with displacement. He underwent open reduction internal fixation (DRIP) surgery and was in a cast for six weeks. His medical bills were \$45,193.45.

The Council authorized settlement of this case in Closed Session on Tuesday, April 16, 2019 (moved by Councilmember Loren Taylor and seconded by Councilmember Noel Gallo - 7 Ayes, 0 Noes, 1 Absent – Councilmember Lynette Gibson McElhaney).

WHEREAS, Mr. Moore sued the City alleging a dangerous condition of public property where he fell, and has agreed to settle his lawsuit for a settlement payment of \$53,030.42; and

**WHEREAS,** the parties and their legal counsel have negotiated a fair and reasonable settlement of these claims; now, therefore, be it

**RESOLVED:** That the City Attorney is authorized and directed to compromise and settle the case of Mario Moore v. City of Oakland, et al., Alameda County Superior Court Case No. RG17885806, City Attorney's File No. 32233, for the sum of Fifty Three Thousand Thirty Dollars and Forty-Two Cents (\$53,030.42); and be it **FURTHER RESOLVED:** That the City Administrator is authorized and directed to issue-settlement payments as negotiated by the City Attorney with Mario Moore and his counsel; and be it
