RECOMMENDATION

Staff Recommends That The City Council Adopt A Resolution Authorizing The City Administrator Or Designee To Accept And Appropriate Grant Funds From The Surdna Foundation In The Total Amount Of Seventy-Five Thousand Dollars (\$75,000.00) To Be Used To Support The Objectives Of The City's Cultural Plan"Belonging In Oakland: A Cultural Development Plan" And The City Of Oakland Participation As A Planning Partner Advising The Surdna Foundation's "Thriving Cultures" Program.

EXECUTIVE SUMMARY

The Surdna Foundation (the "Foundation") wants to advance the Foundation and staff's mutual goals of supporting cultural equity and strengthening Oakland's cultural ecosystem. Acceptance of the grant will support staff participation as a partner in their "Thriving Cultures" program strategy refinement process; a cultural and racial equity impact analysis of the Cultural Affairs Division's program, policies and procedures; and staff efforts to build the infrastructure for cultural equity as articulated in the Oakland Cultural Plan. There is no financial obligation for the City to match this grant.

BACKGROUND / LEGISLATIVE HISTORY

On July 10, 2018, the City Council passed Resolution No. 87271 C.M.S., adopting the Oakland Cultural Plan, "Belonging in Oakland: A Cultural Development Plan" (the "Cultural Plan") which articulated the City's cultural priorities and provides a policy framework, strategies and funding objectives that will strengthen and advance Oakland's Art and Cultural sector.

The Surdna Foundation is a private foundation whose mission is to "foster sustainable communities in the United States — communities guided by principles of social justice and distinguished by healthy environments, strong local economies, and thriving cultures". Their "Thriving Cultures" Program "seeks to foster the conditions in which artists, culture-bearers, designers, and media-makers of color can maximize their potential as leaders, agents of social change, and designers of just systems and communities" by making grants that support the imagination and practice of justice in local communities, the creation of narrative platforms that

Item: _____ Life Enrichment Committee May 14, 2019 amplify the stories and experiences of communities of color, and the expansion of community voices to develop more equitable outcomes across racial lines.

Based on cultural equity principles articulated in the Cultural Plan, the Surdna Foundation will support the Cultural Plan's recommendation to "Perform a cultural and racial equity impact analysis of current programs, policies and procedures and explore asset-based approaches that advance equitu."

Additionally, the Cultural Affairs Division will offer intellectual contributions to the Surdna Foundation Cultures Strategy Refinement process informed by the Division's work in Oakland, and the development of the City's Cultural Plan.

Lastly, the Surdna Grant will also provide support for the Oakland Cultural Plan's stated objective to "strengthen Oakland's cultural ecosystem and build the infrastructure for cultural equity".

ANALYSIS AND POLICY ALTERNATIVES

The Oakland Cultural Plan has been well received locally and nationally as a guide that strengthens Oakland's cultural ecosystem by providing strategies and funding objectives for the division as well as defining cultural priorities for Oakland's cultural stakeholder community. This stakeholder community includes local, regional and national funders, Oakland art organizations and artists, the local non-profit humanities and human services organizations, the local academic institutions e.g. the University of California Berkeley and Mills College, and policy research organizations. e.g. Policy Link, SPUR, and the Haas Institute for a Fair and Inclusive Society. These stakeholders function as associates who are part of the plan's community of implementers.

The Surdna Foundation grant is an investment in the Oakland cultural community that will allow the Division to conduct research into its program activities that will advance the cultural equity objectives stated in the plan and support Oakland intellectual contributions to the Foundation's mission to "foster sustainable communities in the United States — communities guided by principles of social justice and distinguished by healthy environments, strong local economies, and thriving cultures".

It will help build the capacity of Cultural Affairs Divisions ability to fulfil its vision for cultural equity by providing resources to the Division. The grant will support a cultural and racial equity impact analysis of the Division's programs and services; the Cultural Plan's objective to "build the infrastructure for cultural equity" and support the Division's role as a intellectual contributor to the Surdna Foundation's Thriving Cultures Strategy Refinement process informed by the Division's work in Oakland, the development of the City's Cultural Plan, the Division's cultural policy activities as it relates public funding of arts, and the Division's work as an intermediary that advances community cultural development.

Item: _____ Life Enrichment Committee May 15, 2019 Without this grant continuing implementation of the important work of the plan will be delayed. Staff welcomes this grant, which does not ask for any financial contribution from the City.

FISCAL IMPACT

Approval of the resolution will authorize the City to receive and appropriate the \$75,000 grant from the Surdna Foundation to the Miscellaneous Grants Account (2999), Cultural Arts Organization (85511), Cultural Funding Program (CE02) in a project to be established.

PUBLIC OUTREACH / INTEREST

The cultural planning process began in April 2017 and on July 10, 2018 the City Council passed Resolution No. 87271 C.M.S., adopting the Oakland Cultural Plan, "Belonging in Oakland: A Cultural Development Plan" following an extensive community process that has created the Cultural Affairs' Division's action agenda, which has resulted in this grant from the Surdna Foundation. No other outreach was conducted with regard to accepting this grant.

COORDINATION

The Cultural Affairs Division will be working with the Race and Equity Department on the cultural and racial equity impact analysis of its programs.

SUSTAINABLE OPPORTUNITIES

Economic The Surdna Foundation grant will allow the Cultural Affairs Division to conduct research that will inform how our grantmaking economic impact is strengthened through the distribution of these resources in a judicious manner. It also leverages investment by the philanthropic community into Oakland to support the objectives of the Cultural Plan.

Environmental: There is no direct environmental impact associated with the acceptance and appropriation of the Surdna Foundation grant.

Social Equity: The grant will support a cultural and racial equity impact analysis of the Cultural Affairs Division's programs, policies and procedures and help the City explore asset-based approaches that will advance equity and the work of the Division.

WHEREAS, on July 10, 2018 the City Council passed Resolution No. 87271 C.M.S., adopting the Oakland Cultural Plan, "Belonging in Oakland: A Cultural Development Plan" (the "Cultural Plan"); and

WHEREAS, the purpose of the Cultural Plan is to define cultural priorities and provide a policy framework, strategies and funding objectives that will strengthen and advance Oakland's Art and Cultural sector, and

WHEREAS, the guiding vision of the Cultural Plan states, "Equity is the Driving Force, Culture is the Frame and Belonging is the Goal"; and

WHEREAS, the Cultural Plan shapes a course of actions for the Cultural Affairs Division that supports well-being in the City; and

WHEREAS, the Surdna Foundation is a private foundation that operates in communities of color throughout the country and whose mission is to "foster sustainable communities in the United States — communities guided by principles of social justice and distinguished by healthy environments, strong local economies, and thriving cultures"; and

WHEREAS, the Surdna Foundation's "Thriving Cultures" Program "seeks to foster the conditions in which artists, culture-bearers, designers, and media-makers of color can maximize their potential as leaders, agents of social change, and designers of just systems and communities" by making grants that support the imagination and practice of justice in local communities, the creation of narrative platforms that amplify the stories and experiences of communities of color, and the expansion of community voices to develop more equitable outcomes across racial lines; and

WHEREAS, the Surdna Foundation's Thriving Cultures Program has, in the past, supported projects like Designing Justice + Designing Spaces, an Oakland-based nonprofit that uses innovative design and real estate development to address the root causes of mass incarceration and to transform communities;

WHEREAS, based on cultural equity principles articulated in the Cultural Plan, the Surdna Foundation seeks the participation of the Oakland Cultural Affairs Division in the development of their "Thriving Cultures Strategy Refinement" process as a thought partner; and

WHEREAS, as a thought partner, the Cultural Affairs Division will offer contributions to the Surdna Foundation's Thriving Cultures Strategy Refinement process informed by the Division's work in Oakland, the development of the city's Cultural Plan, the Division's cultural policy activities as it relates public funding of arts, and the Division work as an intermediary who works at the intersection of creative placemaking/placekeeping and community cultural development; and

WHEREAS, through the Thriving Cultures Program, the Surdna Foundation proposes to make a grant award of \$75,000.00 to the City of Oakland's Cultural Affairs Division (the "Surdna Grant"), which will be used to pay for staff travel costs related to participation in the Surdna Foundation "Thriving Cultures Strategy Refinement" learning cohort working group in New York City;

WHEREAS, the Cultural Plan's vision, actions, and recommendations align with the Surdna Foundation's mission and "Thriving Cultures" Program and the Surdna Grant will support the Cultural Plan's recommendation to "Perform a cultural and racial equity impact analysis of current programs, policies and procedure and explore asset-based approaches"; and

WHEREAS, the Surdna Grant will also provide support for the Oakland Cultural Plan's stated objective to "strengthen Oakland's cultural ecosystem and build the infrastructure for cultural equity;" now, therefore, be it

RESOLVED: That the City Administrator or her designee is hereby authorized to accept and appropriate grant funds from the Surdna Foundation in the amount of \$75,000 and that the City Administrator is hereby authorized to execute any future grant agreements to accept and appropriate grant funds to support the ongoing work of the Oakland Cultural Plan without returning to Council and be it further; and be it FURTHER RESOLVED: That the Cultural Affairs Division will appropriate the \$75,000 grant from the Surdna Foundation to the Miscellaneous Grants Account (2999), Cultural Arts Organization (85511), Cultural Funding Program (C02) in a project to be established.
